RE: Investigation of 2:00 AM tavern closing time

The Board of the Allentown Association, Inc. wishes to go on record in support of the call by Erie County Clerk Christopher L. Jacobs for an investigation to determine if a 2:00 AM tavern closing time will have beneficial ramifications for Erie County.

Historically, the number one quality of life complaint that is voiced by residents of Allentown is related to negative behavior by intoxicated patrons leaving taverns between the hours of 2:00 and 4:00 am. This loud and disruptive behavior disturbs the peace of residents with direct consequences including property damage to cars, homes, trees and other plantings along with litter brought from taverns and discarded on porches and lawns.

Intoxicated individuals lingering in driveways and entering the rear yards of homes is commonplace in the early morning hours. Noise, damage to cars and property, theft of items from porches and yards, vandalism, public urination, vomiting, street fights and other unsocial acts become far more pronounced in the hours after 2:00 AM.

Further, the disruptive and destructive behavior has increased markedly over the past months. Incidents related to taverns on the Western end of Allen Street are now the number one source of trouble and calls to 911 in Buffalo's B District, which also includes Chippewa Street, parts of Elmwood and the Downtown entertainment district. Buffalo Police have been forced recently to add a special detail to Allen Street that provides officers to patrol Allen until 4:00 AM to combat these identified late night/early morning issues. While this is a welcome element to try to reduce the bad actions of intoxicated bar patrons, this removes officers from the ability to patrol other parts of the district – including other areas of Allentown – and affects the safety of all residents throughout all of B District.

This negative effect of late night tavern patrons is not restricted to Allen Street nor to the City of Buffalo but is a problem that affects neighborhoods throughout the county ranging from village centers to residential streets close to taverns along Sheridan Drive, Niagara Falls Boulevard, Main Street and other locations county-wide.

Because this long standing problem continues to worsen rather than improve, the Allentown Association supports the call for the Legislature to make a serious examination of both the benefits and drawbacks of an earlier closing time and to then make an informed decision by vote of the legislature based on the merits of the investigation.

We ask further that the legislature weigh the opinions of affected residents, not just those of tavern owners and also to consider such benefits as a possible reduction in driving while intoxicated. We ask too that the Legislature look closely at neighboring counties including Niagara and Chautauqua and that of Monroe County (including the City of Rochester) that enforce a 2:00am tavern closing in order to fully understand if there is any true economic impact of an earlier closing given that the vast majority of cities and towns in Western NY enforce the earlier time.

We look forward to a thorough and constructive investigation that results in an informed decision.

On behalf of the Days Park Block Club [DPBC], I am writing to support your proposal of a 2:00 a.m. bar closing for Erie County. The Days Park Block Club STRONGLY endorses the 2 a.m. closing. We hope the Erie County Legislators change the law to mandate the 2 a.m.closing time for taverns rather than the current 4 a.m. closing.

The DPBC, formed in 1987, represents about 60 households surrounding Historic Days Park in Allentown.

I am a lifelong resident of Days Park. When I was younger, there were fewer bars on Allen Street [only 2] between Wadsworth and College Streets. In the last few years, there has been as many as 4-5 on this same one block street. Back in the 50's - early 70's the two bars were family owned neighborhood bars where the patrons would go after work to have a beer or two before going home. They seldom stayed open until 4:00 in the morning. Things were relatively quiet

Now, the Days Park residents experience - on a regular basis, drunken younger patrons breaking beer bottles in the street, urinating on our front lawns or porches, blocking driveways with illegally parked cars. people smoking pot in the park, using profanity and exhibiting sexual behavior in the park, loud obnoxious behavior and damage to our property. Thus "frat house like atmosphere" is totally unacceptable to the Days Park's tax paying residents. The Elmwood Village Charter School, frequently experiences problems in their playground, often during the hours between 2-4 o'clock in the morning.

As noted recently in the Buffalo News, all counties adjacent or close to Erie County, have a countywide 2 a.m. closing time. They also support a significant number of taverns, so it is proven than an earlier closing does not have a killing economic disincentive as some opponents have argued. In fact, some of the research by our community points out that more than 85% of local closing times in the entire country are between 1 and 2 a.m. (http://i.imgur.com/cfU15Pl.gif)

I am writing in support of changing the bar closing time to 2 am. As I see bar owners rallying in opposition of this and getting their die hard drinking patrons to sign petitions I feel the need to write. I also know that it will come down to who has the political clout to sway the politicians. I know that is harsh but it is fact I've dealt with it.

I live within 230 feet of Allen Street and over the past years new bars have been allowed to open and expand without any regard to neighborhoods. The people who live in the neighborhoods around the Allen Street bars have lost a great deal of their quality of life. Friday and Saturday nights are mayhem on our street. I've been woken up one or both nights for months. I can hear the music from the bars and I live over 200 feet away (it does come from the bars because it ends at 4am.) We have yelling and screaming all hours of the night. We have property damage from bar patrons. We have public urination and defecation. It is so common now that there is no need to save proof from security cameras as we just have to record the next weekend.

At a bare minimum if the closing times change we would get another 2 hours of night time quiet. Giving the bar owners a choice to close earlier as I've seen written in a few comments by par owners makes no sense. They have this choice now. And bar owners are the first to push the limits. We have a bar that has an illegal (no permit) dance floor. We have another that has exterior speakers and a TV on a patio. They do as they please and if no one files a complaint then all is well. And even when you do file a complaint it takes years to correct.

Sorry for the minor rant but this reflects the reality of the situation. Many neighbors feel the same. We actually formed a block club specifically to address the bar problems. Thanks to Chief Patterson's efforts and the BPD we have made some progress in dealing with the situation but we have a long way to go. Changing the closing time of the bars to 2 am would be a great help.



Hi Barbara, I come from the industry side of "liquor" and have an opinion on this matter that may be of interest to you.

Hi Barbara, this may come as a surprise being that I sell a brand of alcohol for a living and that under certain logic longer bar hours would create more sales for the brand. However, I tend to believe that if bars closed earlier it would force more people to go out earlier, get to bed earlier and wake up earlier which would then create a healthier, more productive cycle for the community- which is ultimately just better for the culture that we are aiming to foster for the 'New' Buffalo. In addition, I would also argue that this environment may lead to healthier relationships and less violence, as now people are meeting - initially - less drunk, less late and may actually have a chance to have a real conversation with someone; whether that person is a girlfriend, a romantic interest or even a new contact that could open doors in their career. My feeling is that better things may happen in an environment where people are forced to act more mature. This doesn't mean people lose their ability to party until 6am. It just means that those parties are going to happen in a home vs. a bar. This scenario may also help to reduce accidents and deaths from drunk driving, assuming guests are smart enough to spend the night. What is most encouraging is that an earlier curfew would ultimately force a new social culture to emerge in the city. One that is arguably healthier, safer, and possibly more progressive. The economics for industry people to undergo this change could be positive. It is possible that reducing the curfew to 2AM will force the same number of people - and dollars spent - to be allocated earlier in the days. The theory is that all of our bars and restaurants would be bustling with people from 6pm to 2am - vs. the typical 'hit or miss' schedule we have because there is such a big window to 'go out' but not a big enough population to consistently support it. As a bar or restaurateur the idea of narrowing the window with an earlier curfew is intriguing because now you know more

people are coming through the door in a more exact time frame, which could make the business more efficient.

Your proposal sounds good and I understand what you are trying to do. There are a lot of good points there,

But I'm sure you have considered the possibility of the long term infectsheet. such as after hours spots. They would turn up within the residential housing blocks. They would be unlicensed and another way for gangs and criminal elements to support their activities.

The moral condition that our young people are exposed to would suffer another blow by allowing another spot for that type of activity to fester.
