SUMMARY

The Erie County Legislature requested to receive and file this communication pertaining to the Department of Environment and Planning's approval of a work order with Wm Schutt Associates for Erie County Sewer District Nos. 1, 4, & 5 in an amount not to exceed \$50,000.00.

FISCAL IMPLICATIONS

This work does not impact on the County's General Fund. The cost for the engineering inspection work related to this communication will be paid from the 2015 adopted Sewer Fund Operating Budget; Sewer Professional Services Account 516020 of District Nos. 1, 4, & 5.

REASONS FOR RECOMMENDATION

The Division of Sewerage Management has issued work order WS-3 to Wm Schutt Associates to provide resident engineering services. Wm Schutt Associates will provide inspection for various construction and subdivision projects in Erie County Sewer District Nos. 1, 4, & 5.

BACKGROUND INFORMATION

On December 12, 2013, the Erie County Legislature passed a resolution (Comm.20E-9 (2013) authorizing a 3-Year Term Agreement with Wm Schutt Associates. At the time of the contract award, the Division of Sewerage Management committed to notifying the Honorable Legislature of each work order issued.
