SUMMARY

The Department of Environment and Planning (DEP) is seeking authorization for a budget revision for the WNY Stormwater Coalition Municipal Separate Storm Sewer System (MS4) Mapping Project. The budget revision is in accordance with the current project work plan and contractual requirements set forth by the granting agency, the New York State Department of Environmental Conservation (NYSDEC).

FISCAL IMPLICATIONS

There will be no impact on County resources.

REASONS FOR RECOMMENDATION

Approval of this resolution will allow Erie County to complete project obligations according to the current work plan and contractual requirements set forth by the granting agency, the NYSDEC.

BACKGROUND INFORMATION

In 2002, the Erie County Department of Environment and Planning initiated a regional strategy to assist local municipal governments in Erie and Niagara County in understanding and complying with the U.S. Environmental Protection Agency's Phase II stormwater regulations. This strategy included formation of the WNY Stormwater Coalition (WNYSC), a group consisting of representatives from Erie County, Niagara County, several local and state government agencies, 43 regulated entities, and environmental consultants. For the past twelve years the members of the WNYSC have met on a regular basis to collaborate on a comprehensive stormwater management program that complies with State and Federal regulations. The Phase II stormwater requirements include mapping storm sewer conveyance systems in accordance with the NYSDEC's MS4 General Permit (GP-0-10-1002) for stormwater discharges. The WNY Stormwater Coalition MS4 Mapping Project grant is structured to assist the WNYSC membership with meeting this aspect of their General Permit requirements.

CONSEQUENCES OF NEGATIVE ACTION

Without the requested authorization, Erie County will be unable to fulfill its contractual obligations with the NYSDEC.

STEPS FOLLOWING APPROVAL

The grant budget will be revised as indicated.
