# **SUMMARY**

The Department of Environment and Planning (DEP) is seeking authorization for the County Executive or the Deputy County Executive to execute the necessary agreements to accept \$250,000 in grant funding, establish a program budget, and create a Senior Environmental Compliance Specialist (JG-12) position. The grant funding is available from the New York State Energy Research and Development Authority to support the development of an Erie County Climate Action and Sustainability Plan.

# FISCAL IMPLICATIONS

There will be no additional impact on County resources. The requested staff position and program expenses will be funded by the New York State Energy Research and Development Authority (NYSERDA) grant.

# **REASONS FOR RECOMMENDATION**

The anticipated benefits associated with the proposed resolution are as follows:

After this two-year project, Erie County will have a Climate Action and Sustainability Plan in place which will identify projects that can be implemented to reduce the County's impact on the environment, many of which are anticipated to result in cost savings.

# **BACKGROUND INFORMATION**

Erie County recognizes that the potential changes caused by climate change pose serious risks to our health, economy and the environment. Increases in temperature and the resulting changes in precipitation amounts and intensity can cause increased flooding; impact our Great Lakes water levels and water quality; result in algae blooms and invasive species; increase energy demands; and create conditions conducive to air pollution and their associated impacts on health for at-risk populations.

To address this issue locally, Erie County's project will develop a Climate Action and Sustainability Plan to incorporate greenhouse gas (GHG) emission reduction into the daily culture of County employees while setting goals and objectives for GHG emissions reduction and sustainability County-wide. The plan will target County energy use, transportation, waste generation and purchasing, as well as policies that will impact the larger community. To accomplish this Erie County, which has recently signed the Climate Smart Communities Pledge, will establish a Green Team, complete a County-wide GHG inventory and analyze GHG emission sources and levels. Based on this work, Erie County will set a GHG reduction target and develop a Climate Action and Sustainability Plan.

In 2006 the Erie County Legislature adopted the Framework for Regional Growth (FRG). It serves as the County's Comprehensive Plan and provides a blueprint for the area ophysical 6E-8 development. The Erie County Sustainability Plan will update the FRG by incorporating the Page 2 of 5

Climate Action and Sustainability Plan, which will include Smart Growth principles and information related to climate resiliency.

The funding of this program will allow DEP to create a Senior Environmental Compliance Specialist (JG-12) position to manage the grant and act as the County's Sustainability Coordinator, providing leadership for the Erie County Green Team.

# **CONSEQUENCES OF NEGATIVE ACTION**

The DEP will forfeit NYSERDA funding and be unable to access the grant resources to create an Erie County Climate Action and Sustainability Plan.

# **STEPS FOLLOWING APPROVAL**

The necessary contracts with NYSERDA will be executed, a budget will be established, and a Senior Environmental Compliance Specialist (JG-12) position will be created.
