<u>SUMMARY</u>

The County Executive is requesting authorization to enter into an Agreement Amendment with the firm of Watts Architectural & Engineering for providing Environmental Consulting Services for Asbestos Abatement Design, Monitoring and Testing on the Buffalo Niagara Convention Center – 2014 Boiler Stack Replacement and Various County Park Buildings – 2014-Demolition Phase 2 projects.

The Buffalo Niagara Convention Center – 2014 Boiler Stack Replacement project will require a pre-renovation survey, bulk sampling and testing of suspect material, and abatement design and the Various County Park Buildings – 2014 Demolition Phase 2 project will require air monitoring and testing to properly proceed with associated design, construction, and demolition project phases.

FISCAL IMPLICATIONS

Funds for the project are currently available from the approved and adopted 2013 and 2014 Capital Budgets, SAP Projects A.13003 – 2013 Buffalo Niagara Convention Center Rehabilitation and A.14007 – 2014 Countywide Parks Improvements.

REASON FOR RECOMMENDATION

These projects require a pre-renovation survey, bulk sampling and testing of suspect material, abatement design, or air monitoring and testing to properly proceed with associated design, construction, and demolition project phases.

BACKGROUND INFORMATION

There are suspect asbestos containing building materials associated with the boiler stack project that require a survey, testing, and abatement design. The parks demolition phase 2 project requires air monitoring and testing during the demolition of several buildings.

CONSEQUENCES OF NEGATIVE ACTION

If the contract amendment is not approved for hazardous material testing and design, the projects cannot proceed.

STEPS FOLLOWING APPROVAL

Upon legislative approval, an Agreement Amendment will be issued to Watts Architectural & Engineering for providing Environmental Consulting Services for Asbestos Abatement Design, Monitoring and Testing for the Buffalo Niagara Convention Center – 2014 Boiler Stack Replacement and the Various County Park Buildings – 2014 Demolition Phase 2 projects.

COMPTROLLER'S OFFICE REVIEW

The proposed legislation has been reviewed by the Comptroller's Office and is related to an authorized capital project for which there are sufficient appropriations for the action proposed.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to enter into an Agreement Amendment with the firm of Watts Architectural & Engineering, including a design contingency and reimbursables, to provide Environmental Consulting Services for the Buffalo Niagara Convention Center – 2014 Boiler Stack Replacement and the Various County Park Buildings – 2014 Demolition Phase 2 projects for an amount not to exceed \$35,000.00; and be it further

RESOLVED, that the Comptroller's Office be authorized to make payment for all the above from SAP project accounts as follows:

A.13003 – 2013 Buffalo Niagara Convention Center Rehabilitation	\$ 15,000.00
A.14007 – 2014 Countywide Parks Improvements	\$ 20,000.00
For an Amount Not to Exceed:	\$ 35,000,00
