## SUMMARY

The Erie County Department of Law requires a supplemental appropriation made into the 2016 Budget of the Risk Retention Fund ("Fund"). Authorization is requested to appropriate $\$ 1$ million of unassigned fund balance into the Fund order to provide adequate funding for the account.

## FISCAL IMPLICATIONS

$\$ 1$ million in unassigned fund balance will be appropriated into the 2016 Budget.

## BACKGROUND/ REASONS FOR RECOMMENDATION

The County pays for the cost of legal judgments and settlements, as well as outside counsel expenses, from the Fund.

In the 2016 Budget process, the Legislature reduced the funding for the Fund from the Executive-requested $\$ 2$ million to $\$ 1$ million. In the 2015 Budget Balancing Amendments process, the administration requested the rollover and designation of $\$ 2$ million of 2015 positive variance into the 2016 Budget for the Fund and $\$ 1$ million was approved.

Further details regarding the necessity of this supplemental appropriation can be made available to your Honorable Body by the Department of Law in executive session as it relates to pending litigation matters.

## STEPS FOLLOWING APPROVAL

The fund balance would be appropriated into the 2016 Budget and expended, as necessary.
