Dear Honorable Members:

Certain recipients in the Supplemental Nutrition Assistance Program (SNAP) who are considered Abled-Bodied Adults without Dependents (ABAWD) have fallen under new regulations effective January 1, 2016. As a result, the Department of Social Services Comprehensive Employment Division (CED) has begun to provide employment assessments to approximately 2,800 clients not previously required to comply with work activity assignments.

The attached resolution requests authorization to add five full time positions to the Department of Social Services Employment Division in order to meet program staffing requirements necessitated by the changes in the work requirements. The positions are fully reimbursed through newly awarded Federal funding allocated through New York State. Funding will also be available in 2017 for these positions.

SUMMARY

The attached resolution requests authorization to add five full time positions to the Department of Social Services Employment Program in order to meet program staffing requirements necessitated by changes in SNAP eligibility requirements.

FISCAL IMPLICATIONS

The total cost of the five positions with a start date of August 1st, will be \$110,075. The positions are fully reimbursed through newly awarded Federal funding allocated through New York State. Funding will also be available in 2017 for these positions.

REASONS FOR RECOMMENDATION

The new positions requested will provide proper employment assessments and client services in order to assure client compliance with work activity assignments.

BACKGROUND INFORMATION

Certain recipients in the Supplemental Nutrition Assistance Program (SNAP) who are considered Abled-Bodied Adults without Dependents (ABAWD) have fallen under new regulations effective January 1, 2016. As a result, the Department of Social Services Comprehensive Employment Division (CED) has begun to provide employment assessments to approximately 2,800 clients not previously required to comply with work activity assignments. The SNAP Division has also increased their eligibility case screening for the ABAWD population. The Office of Temporary and Disability Assistance (OTDA) provided Erie County with a jurisdictional wavier for the City of Buffalo until December 31, 2016. It is expected that OTDA will no longer issue a jurisdictional wavier in 2017. As a result of no longer being granted a waiver, Erie County will have to implement ABAWD regulations on an additional 8,000 clients.

In order to assure that all ABAWD recipients are complying with work activity assignments the Department is requesting the addition of one Senior Employment Counselor, two Employment Counselors and one Senior Clerk typist

CONSEQUENCES OF NEGATIVE ACTION

Failure to approve this request will result in increased overtime in order to comply with work demands.

STEPS FOLLOWING APPROVAL

Positions will be established and the budget adjusted in accordance with this resolution.
