SUMMARY

The Erie County Legislature is requested to receive and file this communication pertaining to the Department of Environment and Planning's issuance of a work order to Wendel (formerly Audubon Architectures Engineering, Surveying, and Landscape Architecture, P.C.), for Erie County Sewer District No. 5, in the amount of \$38,003.59

FISCAL IMPLICATIONS

There will be no impact on to the County's General Fund. The cost of the engineering work related to this communication will be paid from the Erie County Sewer District No. 5 Professional Services Account.

REASONS FOR RECOMMENDATION

The Division of Sewerage Management has issued work order W-4 to Wendel. Under this task, the consulting engineer will provide the County with Bid Documents to upgrade the Eastern Hills Pumping Station.

BACKGROUND INFORMATION

On November 8, 2012, the Erie County Legislature passed resolution Comm. 18E-9 (2012) authorizing a 3-year Term Agreement with Audubon Architectures Engineering, Surveying, and Landscape Architecture, P.C., now known as Wendel. At the time of the contract award, the Division of Sewerage Management committed to notifying the Honorable Legislature of each work order issued.


