WHEREAS, recent events across the nation and world have shown that heightened awareness and security is necessary in order to protect the public and public assets; and

WHEREAS, a review of the security of the Rath County Office Building requires additional security measures to secure the building, its occupants and guests, including a combination of physical security improvements at entrances, as well as adding security personnel and sworn Sheriff deputies; and

WHEREAS, an estimate for design, construction and equipment is \$605,000 to be paid for as a capital project through SAP in Business Area 122, Fund 410; and

WHEREAS, new positions, both in building guards and in sheriff deputies, are required to be created to properly man and secure the facilities and capital improvements; and

WHEREAS, armed deputies are the most likely responders to any threat posed to the Rath Building and as such would be more valuable than a building guard in an emergency situation.

NOW, THEREFORE, BE IT

RESOLVED, that this honorable body hereby authorizes the creation of six (6) new Sheriff Positions (JG 8/1, annualized salary \$54,113 0 B-100 #8617, one (1) new sergeant (JG 9/5. Annualized salary \$67,900 – B-100 #8616), and five (5) new building guards (JG 4/1, annualized salary \$30,622 – B-100 #8623); and, be it further

RESOLVED, that authorization is provided to the Department of Public Works to appropriate \$605,000 in funds for construction and improvements and the purchase of equipment, including magnetometers, for the Rath Building; and

RESOLVED, that such costs shall be recorded in a project to be created in SAP in Business Area 122, Fund 410; and, be it further

RESOLVED, that the Division of Budget and Management is authorized to make the following budgetary adjustments in SAP to facilitate this request:

RESOLVED, that the Division of Budget and Management, Department of Public Works and Office of the Comptroller are hereby authorized to make any necessary budgetary and financial adjustments to the 2016 Budget for this initiative; and, be it further

RESOLVED, that certified copies of this resolution will be forwarded to the County Executive, the Office of the Comptroller, the Department of Personnel, Department of Social Services, the Division of Budget and Management, Office of the Sheriff, the Department of Public Works, and any other party deemed necessary and proper.

SUMMARY

The Department of Public Works, working in conjunction with the Departments of Emergency Services and Central Police Services, as well as the Office of Sheriff and US Department of Homeland Security, has been evaluating the security of the Rath County Office Building. The security review has determined that additional security measures are necessary to secure the building, its occupants and guests. This includes a combination of physical security improvements at entrances, as well as adding security personnel and sworn Sheriff deputies.

FISCAL IMPLICATIONS

This resolution seeks authorization to create nine (9) new building guards (JG 4/1, annualized salary \$30,622), five (5) new Sheriff deputies (JG 8/1, annualized salary \$54,113), and one (1) new sergeant (JG 9/5, annualized salary \$67,900) at a total cost of \$858,176 for the remainder of 2016. In addition, authorization is requested to appropriate \$605,000 in funds for construction and improvements of entrances and the purchase of equipment (such as magnetometers and metal detectors) for the Rath Building.

The total funding requested is \$1,500,000 which will come from an appropriation of fund balance in 2016.

The County will also be seeking state funding for this project. In the event some amount of state funding is secured, the County's planned use of fund balance will be lowered or not utilized. In addition, potential federal/state reimbursement, in some form, is possible for the work and positions utilized for the Department of Social Services.

BACKGROUND/ REASONS FOR RECOMMENDATION

Recent events across the nation and world have shown that heightened awareness and security is necessary in order to safeguard the public and public assets. Unlike Old County Hall, 25 Delaware Avenue, the Family Court/Probation offices and the Sheriff complex, the Rath Building has no metal detectors and sworn police/armed officers present at the main entrances. This initiative will remedy this, and other security concerns.

Other security improvements including new and improved entrances are included in this project and request.

SUSPENSION

CONSEQUENCES OF NEGATIVE ACTION

The Rath Building will not be as secure as it should or could be given the necessity for increased security in a major public facility.

STEPS FOLLOWING APPROVAL

The Department of Public Works will complete design and seek bids from contractors to conduct the modifications to various Rath Building entrances. In addition, the Department of Personnel will work with the Office of Sheriff and Department of Public Works to canvass civil service lists and/or recruit candidates for the positions.
