WHEREAS, the lease for subsequent years is for 96,453 at a base rent cost of \$19.50 per square foot for the second and third years, and \$19.75 per square foot for the fourth and fifth years; and

WHEREAS, since a lease at 10-12 Fountain Plaza would require the Department to lease less space than 478 Main Street, the cost of entering into a lease for space at 10-12 Fountain Plaza will save taxpayer dollars.

The Department of Social Services is requesting authorization to enter into a lease at the Bank of America Building, 10-12 Fountain Plaza, Buffalo, New York 14202, with Ciminelli Real Estate Corporation for the purpose of housing Social Services programs at the site.

The lease is for the period of March 1, 2017 through March 1, 2022. The County will lease 87,804 square feet for the first year at a base rent cost of \$19.00 per square foot. The square footage to be leased for the subsequent years is 96,453 with a rent of \$19.50 per square foot for the second and third years, and \$19.75 per square foot for the fourth and fifth years. Since a lease at 10-12 Fountain Plaza would require the Department to lease less space than 478 Main Street, the cost of entering into a lease for space at 10-12 Fountain Plaza will save taxpayer dollars.

SUMMARY

The Department of Social Services is requesting authorization to enter into a lease at the Bank of America Building, 10-12 Fountain Plaza, Buffalo, New York 14202, with Ciminelli Real Estate Corporation.

FISCAL IMPLICATIONS

There is no current year fiscal impact for this lease agreement. Since a lease at 10-12 Fountain Plaza would require the Department to lease less space than the existing costs for leasing space at 478 Main Street, the cost of entering into a lease for space at 10-12 Fountain Plaza will save taxpayer dollars.

REASONS FOR RECOMMENDATION

The existing lease will be expiring and the Department must identify space for its programs.

BACKGROUND INFORMATION

The Erie County Department of Social Services is required to lease space due to lack of space in other County-owned buildings. The Family Wellness Division and the Home Energy Assistance Program of the Department of Social Services are currently located at leased space that does not meet their needs, and the current lease expires on February 28, 2017. A Request-for-Proposals was issued for new space and the Department considered several options. The Department concluded the best location for these programs was the Bank of America Building, 10-12 Fountain Plaza, Buffalo, New York 14202, as it was very cost-efficient and would improve staff well-being while providing for client needs.
