#### Summary/Background Information:

The Corporate Training Department of Erie Community College released several "Request for Proposals" for the purpose of recruiting training providers to assist the Corporate Training Department in meeting the training needs of its corporate clients. The goal of these RFP's were to identify qualified Instructors for Advanced Manufacturing and Apprentice/Skilled Trades and Automobile Technician training. Upon completion of the process, the Department has accepted the following vendor proposals. Advantage Resourcing, Arc Training and Consultation, CNC Technical Solutions and Technical Training Support. These vendors will be used to provide high-end advanced manufacturing, apprentice/skilled trades and automotive technician training for existing and future contracted training with companies such as Ford Motor Company (Ford Stamping Plant), General Motors (GM Powertrain), Aurubis, IMA Life and Xylem.

#### Reasons for Recommendation:

To provide expertise in developing and delivering advanced manufacturing, apprentice/skilled trades and automotive technician training courses. As per Eric County guidelines, the Erie County Legislature must approve all consulting contracts above \$50,000.

#### **Fiscal Implications:**

Advanced manufacturing, apprentice/skilled trades and automotive technician related training from the above mentioned companies is expected to bring in at least \$400,000 in revenue for the 2016-17 fiscal year.

# Consequences of Negative Action:

Significant loss of revenue to the College and the inability to meet customer request for training.

Course development and delivery will follow approval.

# ERIE COUNTY LEGISLATURE-PROPOSED RESOLUTION

# <u>Authorization to Enter into Contract to Deliver Workforce Development/Corporate Training</u> Services for Erie Community College

- WHEREAS; The Erie Community College Board of Trustees has approved Arc Training and Consultation Services and Technical Training Services as vendors after the completion of an RFP process at their May 28, 2015, and Advantage Resourcing and CNC Technical Solutions at their June 30, 2016 Board Meeting; approval for the 2016-17 year was reaffirmed for all four vendors at the August 25, 2016 Board Meeting; and
- WHEREAS; Advantage Resourcing is approved to provider hourly training to Corporate Training clients at an hourly rate not to exceed \$55/per hour; Arc Training and Consultation Services at a rate not to exceed \$100 per hour; CNC Technical Solutions at a rate not to exceed \$125 per hour and Technical Training Support at a rate not to exceed \$125 per hour; based on the training needs of corporate clients of the ECC Workforce Development Department; and
- WHEREAS; the Erie County Legislature must approve consulting contracts in excess of \$50,000 for ECC; and
- WHEREAS; Advantage Resourcing, Arc Training and Consultation Services, CNC Technical Solutions and Technical Training Support will deliver customized training programs developed specifically for the corporate clients of the ECC Workforce Development Department; and
- WHEREAS; Advantage Resourcing, Arc Technical Training and Consultation, CNC Technical Solutions and Technical Training Support were chosen in response to various RFPs, including "Automotive Technician Training and Related Services", "Skilled Trades Training and Related Services" and "Advanced PLC/CNC Training and Related Services" based upon their experience and expertise as providers of customized, technical training services; and
- WHEREAS; ECC Workforce Development generates a significant amount of revenue derived directly from technical training programs such as Advanced Manufacturing, Automotive Technician and Skilled Trades/Apprentice training due to the highly technical nature and high quality of instruction received from the ECC Corporate Training Department. In order to maintain and expand the depth and scope of advanced training services, partnerships with vendors such as Advantage Resourcing, Arc Training and Consultation Services, CNC Technical Solutions and Technical Training Services are necessary to offer state of the art training facilities and qualified subject matter experts.
- NOW, THEREFORE, BE IT RESOLVED; that the Erie County Legislature hereby approves awarding a contract to Advantage Resourcing, Arc Training and Consultation, CNC Technical Solutions and Technical Training Support to provide corporate training services for the purpose of fulfilling contractual obligations to corporate clients of the ECC Workforce Development Department.
- **RESOLVED,** that the ECC President is authorized to enter a contract with Advantage Resourcing, Arc Training and Consultation, CNC Technical Solutions and Technical Training Support for the above mentioned services, and be it further
- **RESOLVED,** that copies of the resolution be forwarded to the Erie County Executive, the President of ECC, and the Chairman of the ECC Board of Trustees.
