Over the years, the ENAC Community Center at the Sherman L. Walker Community Center has been in disrepair. We have been in contact with Ms. Mary Beth Pascall, whom we were told to contact when there were problems. However according to Ms. Pascall, she is not sure, who needs to be notified of the problems that exist in the center.

The ENAC felt, at this time, it is necessary to contact you for your help. I have taken this opportunity to list some of the pressing problem that exist:

The ceiling tiles in the rooms need to be replaced (They are missing, broken and stained);

There are major repairs needed in the bathrooms (for whatever reasons there are holes in the walls);

Light bulbs are out or missing;

Light covers are missing;

Some of the trim (baseboards) are missing;

Black Top on patio needs to be replaced;

most importantly the rooms need to be painted.

These are just a few of the issues that need to be address.

We are looking forward to using and having more community based programs in the center, but we need to have these necessary repairs done. If there is anything you can do to help it will be greatly appreciated.
