Dear Mr. Sickler,

I am writing you with the utmost urgency for your department to take immediate action in repairing Erie County roadways within the Town of Collins. The condition of Erie County roads creates an unsafe condition for our residents and the motoring public, and I urge you to implement a plan to upgrade them.

Many of the County roads do not meet the standards required to ensure the safety of the public and we insist that something be done, as this condition will continue to worsen unless a town-wide rehabilitation program is implemented soon. The deplorable condition of your roads, road-sides, and drainage systems is no longer acceptable.

Will you please provide me with your anticipated schedule to make all the necessary repairs and maintenance required, including your plan to implement a comprehensive rehabilitation / replacement program?
