SUMMARY

It is recommended that the County Executive be authorized to execute a contract for geographic information systems needs assessment report.

FISCAL IMPLICATIONS

The Bergmann and Associates assessment will not exceed \$9,500. Funding is available within SAP Project B.16004 Asset Management Software.

REASONS FOR RECOMMENDATION

Erie County Division of Highways is operating below its potential due to significant gaps in information needed to support efficient operations. Geographic Information Systems [GIS] have proven to be an excellent platform to catalog and detail the assets and operations for DPW.

BACKGROUND INFORMATION

The County has 294 bridges, 1,200 centerline miles of roads and hundreds of pieces of equipment. The age and lack of standardized data, high staff turn-over, time consuming asset research and the potential for reactive management can cost the Division time and money. The Division would be improved and able to present information regarding road closures, restrictions and asset inventories utilizing ESRI software. The GIS software assists with the filing of reports for NYS and Federal agencies, as well as tracking asset life cycles.

CONSEQUENCES OF NEGATIVE ACTION

Asset management, constituent response and pro-active planning are all handicapped by the lack of consistent and accurate data. Without the GIS technology DPW would be less efficient and may lack the data needed for responsive formal reporting.

STEPS FOLLOWING APPROVAL

The County Executive will execute a contract with Bergmann and Associates. Information from the engineering consultant will determine needed follow-up actions.
