Dear Mr. Geary:

Can you please direct your road crews to pave and stripe the above roads with crosswalks as well as faded double yellow lines? The following roads need serious road work during school hours in order to prevent traffic disruption in the morning and afternoon.

#### Pleasantview Dr.-

- 1. Is in horrible condition. The road is raised in 21 areas.
- 2. There are no sidewalks or bike and walker paths.
- 3. There are no crosswalks at Pleasantview Dr. and Transit Rd.
- 4. The right hand turn lane needs to be completely redone, lengthened and restriped. There are pot holes 2 feet deep. They were repaired last year, but your crews did a horrible and half ass job.
- 5. The left hand turn lane needs to be lengthened and restriped.
- 6. 2 left hand turn lanes need to created at Warner Rd. and Heritage Heights Rd.

#### 4th, 5th and 6th street, off of Como Park Blvd.-

- 7. Need to be repaired and repaved.
- 8. Cross walks need to be painted on the roads. Children and Grandchildren as well as grandparents walk their children to Como Park Elementary School.

## St. Mary's Street between Pleasant Ave. West and the railroad tracks-

9. Crosswalks need to be placed at all 3 intersections; Broadway and Aurora, Aurora St. and Pleasant Ave. West and St. Mary's street near the cemetery.

## <u>Sheldon Ave. and Walden Ave. - Children walk to Our Lady of Pompei and St. Mary's High</u> School-

- 10. Needs to be milled and paved.
- 11. Crosswalks need to be reapplied.
- 12. Crosswalks need to be reapplied at the intersection of Sheldon Ave. and Lavarack Ave.

Lancaster residents and school parents have asked the Town and Lancaster Highway to do these repairs for 2 years, and they have refused to comply.

Lancaster is the third highest of taxes in Erie County and our roads are horrible. It is 1 week before school and repairs have not been made for the safety of parents and children.

## Central Ave. between Walden Ave and Pleasant Ave. West-

- 13. Needs to be repaved.
- 14. Needs a new double yellow. Motorists pass each other all the time!
