Continued funding for this request is available through vacancy savings in the Medical Examiner's Office's Full Time Salary and Fringe Benefits lines.

MEMORANDUM

Re: Authorization to Contract with Forensic Pathologist Fee-for-Service

Date: October 13, 2017

SUMMARY

Authorization is requested to enter into a contract with one individual fee-for-service pathologist associated with the respondents of an RFP issued by ECDOH.

FISCAL IMPLICATIONS

There are no immediate fiscal implications. Approximately \$100,000 in initial funding was made available through vacancy savings in the Full Time Salaries and Fringe Benefits accounts of the Medical Examiner's Division.

REASONS FOR RECOMMENDATION

The Associate Chief Medical Examiner departed the office on June 23rd. The Chief Medical Examiner has returned from medical leave but, this still leaves Erie County with a two Medical Examiners to cover a tremendous amount of work. An RFP was issued to solicit the services of FFS pathologists willing to travel to Buffalo on a rotating basis to fill these shifts. 6 respondents replied and all were deemed qualified and able to work the need shifts. Since then, some of those rotating pathologist have moved on to other contractors or have stopped doing FFS work. An additional FFS pathologist associated with the previous RFP applicants is available to be slotted in.

BACKGROUND INFORMATION

Due to the national shortage of Medical Examiner, several major counties including Onondaga and Monroe have successfully solicited the services of FFS pathologists to fill in when staffing shortages occurred. FFS pathologist in some cases work part-time or full-time at other offices and use their personnel leave to work in other jurisdictions. ECDOH previously followed RFP protocols to find qualified individuals, and identified vacancy savings to cover the initial cost of these contracts.

CONSEQUENCES OF NEGATIVE ACTION

The Erie County Department of Health- Division of the Medical Examiner would be hard pressed to meet timely goals. Major delays in homicide, suicide, motor vehicle, and drug overdose death investigations would occur. Significant impacts to the criminal justice system and court cases including homicides could occur.

STEPS FOLLOWING APPROVAL

The Health Department will work with the Division of Budget and Management, the Department of Law and the Office of the Comptroller to implement this request.

A RESOLUTION SUBMITTED BY HEALTH DEPARTMENT

RE: Authorization to Contract with Forensic Pathologists Fee-for-Service

WHEREAS, the Erie County Department of Health provides forensic medical services through the Office of the Medical Examiner; and

WHEREAS, the need for expert pathological skills is critical for the function of the medical examiner's office; and

WHEREAS, the Erie County Medical Examiner's Office provides crucial support and determinations to the law enforcement community; and

WHEREAS, the Erie County Medical Examiner's Offices faces a temporary staffing shortage; and

WHEREAS, fee-for-service forensic pathology services are available to cover staffing shortages on an interim basis; and

WHEREAS, an RFP process was previously performed to solicit respondents willing to perform fee-for-service on a rotating basis in Erie County; and

WHERAS, changes in availability have limited the ability of all of the respondents to continue working in Erie County necessitating the addition of one FFS pathologist on a short-term basis.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to enter into a contract with Jay Stahl-Herz, M.D.; and be it further

RESOLVED, that the Erie County Legislatures waives the RFP process for this individual contract; and be it further

RESOLVED, that the following fee scheduled is adopted for this contract based on RFP# 1707VF
