MEMORANDUM

To: Honorable Members of the Erie County Legislature
From: Department of Homeland Security and Emergency Services
Re: Acceptance of FY 2016 Technical Rescue Grant
Date: March 20, 2017

SUMMARY

The Department of Homeland Security and Emergency Services is seeking authorization for the County Executive to enter into contract to receive \$139,000 in Federal Assistance for the FY 2016 Technical Rescue Grant.

FISCAL IMPLICATIONS

There is no fiscal impact on the county operating budget. Said grant is 100% reimbursed.

REASONS FOR RECOMMENDATION

The Department of Homeland Security and Emergency Services will be allowed to manage expenditures for \$139,000 in Department of Homeland Security funds and utilize the funds to enhance the ability of Erie County to manage emergency and disaster situations.

BACKGROUND INFORMATION

As a result of existing threats to homeland security, the federal government through various State agencies has allocated funds to be utilized to improve the preparedness of local technical rescue teams. This grant has given us, the local stakeholders, the opportunity to strengthen our chemical, biological, radiological, nuclear and explosive (CBRNE) Preparedness and Response Capabilities. This grant is a regional grant which is defined as multiple agency teams who provide technical rescue services countywide or regionally to multiple counties. Our grant application was made up of five (5) fire departments, one (1) swift water rescue team, one (1) not for profit search and rescue team and the Erie County Sheriff's Office.

CONSEQUENCES OF NEGATIVE ACTION

Without this Legislation the Technical Rescue Grant Year 2016 contract will not be signed, the funding will not be received by the Department of Homeland Security & Emergency Services and the original purpose of what these funds were intended to be utilized will not be completed.

STEPS FOLLOWING APPROVAL

The County Executive will sign the contract, the \$139,000 in Homeland Security grant funds will be received, and the Department of Homeland Security and Emergency Services will fulfill the grant requirements.

WHEREAS, the Department of Homeland Security through the NYS Department of Homeland Security and Emergency Services has agreed to provide funding in the amount of \$139,000 in federal assistance to provide local stakeholders, that provide technical rescue services, the opportunity to strengthen their chemical, biological, radiological, nuclear and explosive (CBRNE) Preparedness and Response Capabilities which will ultimately enhance the ability of Erie County to manage emergency and disaster situations; and

WHEREAS, authorization is required from the Erie County Legislature for the County Executive to enter into contact and accept \$139,000 in federal resources to provide funding for training of personnel and the purchase of necessary equipment to enhance the ability of Erie County to manage emergency and disaster situations; and

WHEREAS, this is a regional grant and Erie County will purchase the necessary equipment and training for the five (5) local Fire Departments (Gowanda Fire Company, Orchard Park Fire Company, Hillcrest Fire Company, West Falls Fire Company and East Aurora Fire Department), the Erie County Sheriff's Office, the Niagara Frontier Search and Rescue Team and the Western New York ALERT Swift Water Rescue Team; and

WHEREAS, authorization is requested from the Erie County Legislature for the County Executive to enter into Memorandums of Understanding to give the purchased equipment from this grant to those agencies.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature does hereby authorize the County Executive to enter into contract with the NYS Department of Homeland Security to receive \$139,000 in grant funding to meet the goals and objectives under the Department of Homeland Security and Emergency Services; and be it further

RESOLVED, these funds will be utilized to enhance the ability of Erie County to manage emergency and disaster situations; and be it further

RESOLVED, that the Department of Homeland Security and Emergency Services can enter into Memorandum of Understanding Agreements (MOU's) with the five (5) local Fire Departments (Gowanda Fire Company, Orchard Park Fire Company, Hillcrest Fire Company, West Falls Fire Company and East Aurora Fire Department), the Erie County Sheriff's Office, the Niagara Frontier Search & Rescue Team and the Western New York ALERT Swift Water Rescue Team for the local stakeholders purchase of equipment and training by Erie County; and be it further

RESOLVED, that the authorization is hereby provided to the Division of Budget and Management to establish funding in the grant fund 281, funds center 16700 as follows:
