SUMMARY

Recommend approval of the attached resolution to allow the Erie County STOP-DWI Office to accept a donation of \$12,233.30 from Crusade Against Impaired Driving, Inc., (CAID).

FISCAL IMPLICATIONS

No match is required.

REASONS FOR RECOMENDATION

In order to accept the donation, the STOP-DWI Office requires authorization of the County Executive and the Legislature to adjust the 2018 budget to reflect additional revenue.

BACKGROUND INFORMATION

On March 6, 1998, Karen Kwiatkowski was killed in a crash caused by a drunken driver. In the aftermath of Karen's death, the Kwiatkowski family established a 501c-3 foundation called CAID – Crusade Against Impaired Driving, Inc. The foundation organized vigils and activities to raise funds to promote awareness of the dangers of impaired driving. Early in 2018, the Kwiatkowski family contacted the STOP-DWI Office to report that they were ending foundation activities and wanted to donate the balance of foundation assets to the STOP-DWI Office. Funds will be used to support a DWI public perception survey and procure traveling exhibits for display at Erie County high schools and public events. The Nixon Peabody Law Firm donated legal services to properly close the accounts of the foundation in accordance with regulations of 501c3 organizations.

CONSEQUENCES OF NEGATIVE ACTION

Failure to adopt this resolution will forgo the benefit of the financial resources and the additional victim service and public education projects afforded by the generosity of the Kwiatkowski family.

STEPS FOLLOWING APPROVAL

Upon approval, the STOP-DWI Office will coordinate with the Division of Budget & Management and to increase the STOP-DWI 2018 budget to reflect the additional revenue. Certified copies of the resolution shall be sent to the County Executive's Office, the STOP-DWI Office, Division of Budget & Management, and the Comptroller's Office.

WHEREAS, Crusade Against Impaired Driving, Inc. (CAID) was established by the Kwiatkowski family in memory of Karen Kwiatkowski, victim of a crash caused by an impaired driver on March 6, 1998; and

WHEREAS, the Kwiatkowski family has accumulated a distinguished record of service to the residents of Erie County; and

WHEREAS, the work of the CAID Foundation and the Kwiatkowski family has improved public awareness of the danger of impaired driving and contributed to the decrease of impaired driving fatalities in Erie County; and

WHEREAS, the CAID Foundation has concluded operations and the Kwiatkowski family wishes to donate \$12,233.30, the balance of CAID financial resources, to the Erie County STOP-DWI Office;
