Chair Savage:

As you are aware, public buildings present a security challenge in today's changing world. At County Hall and the numerous Auto Bureau offices open to serve the public, employees have direct contact with over 750,000 customers each year and must be prepared for any isolated event or threat.

Eighty-five persons are employed full or part-time in the Erie County Clerk's Office in several departments located at 92 Franklin Street. Security at County Hall is provided by State Court Officers; and despite the fact that the primary responsibility of the Court Officers is protection of the Court personnel, excluding county personnel, the County Clerk's Office relies upon the Court Officers to answer distress calls and prevent weapons from being carried into the building.

Ninety-seven employees work at the ten local Erie County Auto Bureau Units and one mobile Pistol Permit Office. These ninety-seven employees process an average of 50,000 transactions monthly and an average of 40,000 – 50,000 Erie County residents enter Erie County Offices to do business. In all but one office, no security officer is available in the event of an emergency.

Only the Auto Bureau at 170 Pearl Street is provided officers directly by the County based on the justification that the office is located in a "government building." Security is provided in only one other office, by a private contractor and on Saturdays only. At the remaining nine locations, all occupied by lease or agreement with the County, employees and customers alike must rely on officers provided by third parties or wait for a response from a 911 call.

Enclosed with this correspondence is a list of the County offices and information concerning the extent and availability of any security or safety officer(s).

I am requesting assignment of this issue to the appropriate committee and ask for an opportunity to correct this inequity. I am available at the convenience of this honorable body to more specifically discuss details and provide additional information.
