ACCOMPANYING MEMORANDUM

Re: Erie County Sheriff's Office – Seized Assets Fund Transfer

I. Summary of Recommended Action

The attached resolution has been requested by the Sheriff's Office to allocate funds from the Asset Forfeiture Trust Account to purchase new mobile data terminals and mount brackets.

II. Fiscal Implications of Proposal

Funds in the amount of \$45,000.00 will be transferred from the Asset Forfeiture Trust Account. There will be no impact on county tax dollars.

III. Reasons for Recommendation

The Sheriff's Office Detectives Bureau needs ten new mobile data terminals (also known as laptops). Currently, Detectives perform most of the report writing and research at desktops. The new laptops would increase the Detectives' work efficiencies and the upgraded software components would allow greater access to information while working away from the office.

IV. Consequences of Negative Action

Failure to approve this request will leave Detectives without functional laptops in their vehicles and force the Detectives to return to an office or substation to complete investigations and reports.

V. Steps Following Approval of Measure

Certified copies of this resolution will be forwarded to the Division of Budget and Management, Erie County Comptroller, and the Sheriff's Office for implementation.

WHEREAS, the new laptops and upgraded software would allow the Detectives to remain at a scene or away from the office while conducting investigations and provide them means to author reports and do research; and

WHEREAS, as of July 2, 2018, the Seized Asset Forfeiture Account balance is \$307,767.10; and

WHEREAS, the funds transferred from the Seized Assets Forfeiture Account for equipment is an U.S. Department of Justice authorized expenditure.
