Dear Honorable Members:

The Department has been awarded \$25,000 in 100% State share funds as a graduated community in the Safe Harbor for Exploited Children program. This proposed resolution authorizes the Department to amend the 2018 Adopted Budget and to renew a contract with the International Institute as the lead agency for this program funding. As International Institute has been the lead agency for this program for the previous five years, this proposed resolution seeks Legislative authority to waive section 19.08 of the County Administrative Code which otherwise requires that a Request for Proposals (RFP) be conducted.

The State legislature passed the Safe Harbor for Exploited Children Act. A key provision of the Act is to move sexually exploited youth from the criminal and juvenile justice systems to the family court where children and their families can receive support and services from the child welfare system. Services are to be provided to victims of sex trafficking, and core elements of the service include case management, emergency temporary housing, health care, mental health counseling, language interpretation and translation services, job training and placement and services to assist in establishing permanent residence. Erie County participated in this program for five years, with International Institute as the lead agency. It is now eligible for funding as a graduated community.

SUMMARY

This proposed resolution authorizes the Department to amend the 2018 Adopted Budget and to renew a contract with the International Institute as the lead agency for this program funding.

FISCAL IMPLICATIONS

There is no fiscal impact to the 2018 Adopted Budget as a result of this resolution.

REASONS FOR RECOMMENDATION

The Department has been awarded \$25,000 in 100% State share funds as a graduate community of the Safe Harbor for Exploited Children program. Services are to be provided to victims of sex trafficking and core elements of the service include case management, emergency temporary housing, health care, mental health counseling, language interpretation and translation services, job training and placement and services to assist in establishing permanent residence.

BACKGROUND INFORMATION

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to enter into contract with the State of New York to accept funding for the Safe Harbor for Exploited Children program; and be it further

RESOLVED, that the Commissioner of Social Services and/or the County Executive are hereby authorized to enter into a subcontract with the International Institute in order to implement the Safe Harbor for Exploited Children program; and be it further

RESOLVED, that the following budget amendments are hereby authorized in the 2018 Adopted Budget:
