WHEREAS, the Erie County Sheriff's Motorcycle Unit has a long history of providing public and traffic safety; and

WHEREAS, the Motorcycle Unit provides traffic and escort services for visiting dignitaries and during special events; and

WHEREAS, the Motorcycle Unit allows the Erie County Sheriff's Office (ECSO) to utilize these fast and maneuverable vehicles to lead motorcades and conduct traffic control duties, which frees additional road patrol vehicles for other posts and duties; and

WHEREAS, the ECSO's current fleet consists of six motorcycle, four of which are 4-yearsold or younger; and

WHEREAS, the ECSO will replace a 16-year-old motorcycle which is experiencing more mechanical issues as well increasing costs to maintain; and

WHEREAS, the agency planned to include the new motorcycle in the coming 2020 budget, but due to a necessary major repair and the upcoming NFL season, the Sheriff's Office seeks to utilize seized asset funds to replace the 16-year-old motorcycle; and

WHEREAS, the Asset Forfeiture Trust Account balance as of June 10, 2019, is \$425,582.00; and

WHEREAS, this acquisition will not have any fiscal impact on the 2019 County Budget.

2. INTRO. 15-3 (2019)

LORIGO, MILLS, DIXON & RATH AS AMENDED

WHEREAS, the Sheriff has indicated a willingness to pursue a body camera program for some of the officers within the Sheriff's Office; and

WHEREAS, on May 23, 2019, this Honorable Body appropriated \$600,000 in funding in the 2018 Budget Balancing Amendments into the 2019 Budget to the Division of Information and Support Services ("DISS") for the purpose of developing a body camera program in the Erie County Sheriff Office; and

WHEREAS, in deliberately appropriating these funds in DISS, the Legislature hoped and expected that the Erie County Sheriff Office would work in conjunction with DISS, the County's information technology department which oversees and implements all County departments' technology, computer and hardware and software projects, on the development and issuance of a request for proposals ("RFP") for the body camera project; and

WHEREAS, on June 27, 2019, Legislature Chairwoman April Baskin sent a letter to Sheriff Timothy Howard and County Executive Mark Poloncarz requesting a status update on the RFP process, resulting in Sheriff Timothy Howard sending a response letter on July 8, 2019 stating his office had already issued a RFP and responses were due on July 10, 2019, and requesting that the Legislature transfer the funding from DISS to the Sheriff Office "as not to create any delays in the implementation of the Erie County Sheriff's body camera program"; and

WHEREAS, on July 11, 2019, at the Legislature's joint caucus a Sheriff representative admitted, under questioning, that their office had not been in contact with, or attempted to work with DISS on the body camera RFP and project; and

WHEREAS, on July 11, 2019, in comments at the Legislature joint caucus, the Sheriff Office stated that they received eight (8) responses to their body camera RFP but insisted that they could not, and would not open the RFP responses or act to advance the body camera program until such time as the funding was transferred to their budget and stated that legally they could not move the body camera project forward without the funding being moved from DISS; and

WHEREAS, on July 11, 2019, the Erie County Attorney's Office issued a legal opinion noting that such an assertion or claim was not accurate or true and no prohibitions exist whatsoever that limited or inhibited the Sheriff Office from opening and reviewing the responses and continuing the RFP process; and

WHEREAS, on July 11, 2019, Chairwoman Baskin sent a letter to Sheriff Howard noting that no prohibitions limited his office from working on the RFP, and urged him to move forward with the RFP review and selection process with the County's Chief Information Officer from DISS, to which no reply has been made by the Sheriff; and

WHEREAS, in testimony at a Legislature Committee hearing on July 17, 2019, a different representative from the Sheriff Office stated that they had not yet opened the eight RFP responses or convened a review committee for the body camera project, and stated that they could not do so until such time as the funding was moved from DISS; and

WHEREAS, there is a strong sentiment in the Legislature that the body camera project should be moving forward without delay and that the Sheriff Office should, as it agreed it would in the Sheriff's July 8th letter, immediately work with DISS and the County's CIO on the RFP review and selection process; and

WHEREAS, this resolution expresses the Legislature's support for the body camera project and its immediate implementation following an RFP review and selection process involving the Sheriff Office and DISS and urges the Sheriff to act without delay on the RFP review.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its support for, and intention to transfer the \$600,000 in funding for the Sheriff Office body camera project at a legislative session in September 2019 from the Division of Information and Support Services to the Sheriff Office, contingent upon the Sheriff Office: (1) fully including DISS in the request for proposal review and selection process in July and August 2019; (2) sending a request to enter into contract with the recommended body camera vendor by the Legislature's September 26, 2019 legislative session, which corresponds with the Sheriff's RFP timetable that planned their selection of a winning vendor on August 30, 2019, during the Legislature's recess; and be it further

RESOLVED, that the \$600,000 in funding to be transferred from DISS to the Sheriff Office, subject to the above-conditions being satisfied, shall be specifically reserved and utilized only for a program to implement body cameras for Sheriff deputies controlled by the Erie County Sheriff Office, and for no other purpose unless otherwise approved by the Erie County Legislature; and be it further

RESOLVED, that the Director of Budget and Management is hereby authorized to make any required 2018 and 2019 budgetary adjustments to implement the budgetary amendments authorized in this resolution; and be it further

RESOLVED, that certified copies of this resolution be sent to the County Executive Mark Poloncarz, the Erie County Sheriff Timothy Howard, the Department of Budget and Management, the Department of Information and Support Services, and any other party deemed necessary and proper.

WHEREAS, local governments spend millions of dollars annually to collect and manage a small fraction of unwanted paint through household hazardous waste collection programs; and

WHEREAS, eight states and Washington, DC have passed their own paint stewardship laws which are estimated to have saved taxpayers over \$69 million, created over 200 jobs, and led to the recycling of over 17 million gallons of high-quality paint; and

WHEREAS, legislation has been introduced in the New York State Assembly (Bill A.6373 and Senate (Bill S.4351, sponsored by State Senator Timothy Kennedy) that would amend the state's environmental conservation law in order to establish a post-consumer paint collection program; and

WHEREAS, the Senate has passed the legislation and the bill is awaiting Assembly action; and

WHEREAS, the bill would establish a Post-Consumer Paint Collection Program to manage leftover household paint, with all architectural paint manufacturers selling in New York being

required to fund the program through a cost-based, independently audited assessment added to their current price of paint which would reduce local and state government costs, increase resident convenience, and create new jobs in recycling and manufacturing; and

WHEREAS, the bill has drawn the support of a range of environmental advocacy organizations, paint industry representatives, and municipal agencies, as well as the New York State Association of Counties.

WHEREAS, SUNY Erie Community College (the College) has neglected to accurately maintain the physical space inventory database both with SUNY Central and internally resulting

in an unusable space inventory for the Academic and Facilities Master Plan process; and

WHEREAS, an accurate assessment of the College's facilities is vital to the meaningful completion of the Academic and Facilities Master Plan project currently underway; and

WHEREAS, JMZ Architects and Planners, P.C. (JMZ), the winning vendor in the Academic and Facilities Master Plan RFP, had attempted to do a simple update to the College's space inventory within the dollars already available; and

WHEREAS, it was discovered during the course of this attempt that the space inventory documents on hand were significantly different than the actual spaces being used at each campus, facilitating the need for a complete space audit for all three campuses including basic footprint measurements; and

WHEREAS, the College has already selected JMZ and their partners as the vendor for the Master Plan; and

WHEREAS, JMZ and their affiliated partners are already in place and intimately familiar with the College's campuses from this project and have already made good progress on identifying those campus areas that do not match inventory records; and

WHEREAS, the RFP proposal offered by JMZ stated it would use these records to keep the cost to complete the audit low; and

WHEREAS, if the College had known the space inventory records were not accurate this would have been a key deliverable of the RFP; and

WHEREAS, JMZ was the lowest bidder and best proposal of services vendor during the RFP; and

WHEREAS, going out with an RFP for a space audit would add months to the Master Plan project timeline and almost certainly result in JMZ winning since they already have a head start on any other vendors submitting a proposal (familiarity with the campuses, where the deficiencies are, and exiting documentation of their work); and

WHEREAS, based on the amount of work already done by JMZ related to this space audit need, and on average hourly rates for architectural work of this type, it is estimated that any other submissions for a new RFP would come in \$30,000 to \$40,000 higher than the not to exceed amount of \$70,000 being proposed by JMZ to provide the same updated space inventory records; and

WHEREAS, the SUNY Erie Community College Board of Trustees resolved at its last meeting, June 27, 2019, that having the current vendor, JMZ Architects and Planners, P.C., conduct the space audit would provide the best result for the College in terms of timely and cost effective completion of the Academic and Facilities Master Plan, a plan that will be at the core of the next SUNY Erie Community College Strategic Plan; and

Insurance (INTRO. 16-1)

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS BRUSO, MEYERS & JOHNSON

WHEREAS, many homeowners in New York State live in areas in which their homes lie in flood plains or other locations and their property insurer or mortgage company require them to obtain compulsory flood insurance; and

WHEREAS, legislation has been introduced in the New York State Assembly and State Senate which would prohibit mortgagees from requiring mortgagers to purchase flood insurance exceeding a coverage amount that exceeds the outstanding mortgage thereon, or that includes coverage for contents; and

WHEREAS, the legislation would limit a homeowner's requirements when purchasing compulsory flood insurance and provide notice of the minimum insurance liability that is required. Under the bill, homeowners would not be required by law to buy flood insurance that exceeds the outstanding amounts owed to the bank or covers content within the home; and

WHEREAS, in notifying the homeowner of minimum flood insurance requirements, the notice would include a statement informing the homeowner that minimum flood insurance only covers the bank's interest and may not cover the full value of the home or the belongings inside; and

WHEREAS, that legislation, Assembly Bill A.4770 and Senate Bill S. 4629-A, expands the current real property law to include requirements to produce notice between mortgagee and mortgagor on the minimal purchase needed for compulsory flood insurance; and

WHEREAS, the legislation helps ensure homeowners are not burdened by additional coverage by insurance companies and banks when mandated to purchase flood insurance; and

WHEREAS, the Senate Bill was approved by the State Senate and the Assembly Bill is awaiting action by the State Assembly.

NOW, THEREFORE, BE IT

RESOLVED, the Erie County Legislature expresses our support for Assembly Bill A.4770 and urges the State Assembly to approve this legislation to help protect homeowners who are required to purchase flood insurance and to help ensure that they are not required to purchase flood insurance coverage beyond the amount of the balance of their mortgage that protects their mortgagor; and be it further

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS BASKIN, BRUSO, JOHNSON, HARDWICK, CHIMERA & MEYERS

WHEREAS, recently, an individual from our community published a 'letter-to-the-editor' of the Buffalo News lamenting the difficulty of finding electronic recycling events to recycle his old, unused electronic items, batteries, and televisions; and

WHEREAS, under New York State law, the State Department of Environmental Conservation has established regulations and policies for the recycling of consumer electronic waste, among which, consumers are barred from disposing of many types of electronic equipment in their trash/garbage and they are required to use either (1) a manufacturer's takeback recycling program; or (2) go to an electronic waste collection site or participate in an electronic waste collection/recycling event, such as those often hosted by local governments in Western New York, like Erie County's periodic e-waste collection events; and

WHEREAS, most consumers have absolutely no idea or understanding that State law requires manufacturers to take-back their items for recycling upon demand by the consumer, and that the manufacturer is also required, in some cases, to pay for the postage/shipping expense; and

WHEREAS, many retailers and manufacturers, however, require the consumer to pay a fee, such as \$20.00 or \$25.00 per item, to drop-off and recycle a television; and

WHEREAS, most of the non-retail collection sites and events – but not all – refuse to accept televisions, including older tube televisions (cathode-ray tubes) and tube computer monitors; and

WHEREAS, many of these events, if not all, are wildly popular and people line up for an hour or longer in their vehicles in lines in order to recycle their e-waste, with some people not being able to recycle their items when the collection event is full and cannot accept more items; and

WHEREAS, despite these constraints, history shows that local consumers want to recycle their electronic items, and we should support recycling; and

WHEREAS, Erie County, like other local governments, works with Sunnking, an approved electronic recycling vendor, to conduct e-recycling events around our county, in which many items are accepted for recycling, including monitors, and flat-screen and cathode-ray tube (CRT) televisions (but not broken or bare CRTs) and communicates those events on a special website at the

Erie County Department of Environment and Planning (http://www2.erie.gov/recycling/index.php?q=electronics-recycling); and

WHEREAS, the Electronics Take Back Coalition also encourages and provides detailed information to consumers showing options for voluntary manufacturer takeback programs in which consumers can take used devices to partnering stores or collection sites for free, or receive a free mail-back (see http://www.electronicstakeback.com/how-to-recycle-electronics/manufacturer-takeback-programs/); and

WHEREAS, this Honorable Body desires to communicate to the public the importance of recycling their consumer electronic items through some of these mechanisms, and to underscore the availability of e-waste collection events, such as those coming up on Saturday, July 27, 2019 from 9 am-12 pm at Apple Tree Business Park in Cheektowaga and on August 10, 2019 from 9 am-12 pm at Tonawanda Senior High School in the City of Tonawanda; and

WHEREAS, this Honorable Body wishes to express our support and encouragement to the Erie County Department of Environment and Planning to work with our city, town and village governments to help conduct more no-charge e-waste collection events in our community and to conduct more public announcements and visibility to communicate these events to the public.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses our support for the County's electronic waste recycling programs and the Erie County Department of Environment and Planning's efforts to encourage and promote more e-recycling; and be it further

RESOLVED, that this Honorable Body expresses our support and encouragement to the Department of Environment and Planning to work with Sunnking and local town, city and village governments to conduct more e-recycling collection events and more publicity and visibility announcing such events to maximize consumer participation; and be it further

WHEREAS, this agreement ensures the ECSO assigns a dedicated Community Reintegration Deputy to coordinate all related programs for Project Blue; and

WHEREAS, the Community Reintegration Deputy will facilitate the development, implementation, execution, and evaluation of the program; and

WHEREAS, Hope of Buffalo Inc. will reimburse the Erie County Sheriff's Office and the County of Erie \$66,000.00 (\$55,000.00 salary and \$11,000.00 for fringe benefits) for each year of the agreement for the Community Reintegration Deputy salary; and

WHEREAS, the ECSO is not creating a new Deputy Sheriff position, rather it will designate a current sworn employee to the collaboration; and

WHEREAS, the MOU shall remain in effect for no longer 36-months from the date of its execution; and

WHEREAS, the MOU may be terminated, without cause, by either party with upon 30-days of written notice.

NOW, THEREFORE, BE IT

WHEREAS, Erie County has solicited proposals from qualified firms for proposals to perform an Engineer Assessment for a New or Expanded Convention Center in Erie County; and

WHEREAS, Erie County has conducted a consultant selection process in conformance with Section 19.08 of the Erie County Administrative Code a consultant; and

WHEREAS, Erie County desires to work with TVS Design to perform an Engineering Assessment for a New or Expanded Convention Center; and

Dear Chairwoman Baskin:

In accordance with the obligations of the Erie County Attorney set forth in subsection 3, Section 204 of Article 2 of the Erie County Charter, this legal opinion concerns Local Law Intro No. 8-1-2019 (8-1).

Preemption

Under New York state law, preemption occurs when a local law directly conflicts with a state statute, or where a state statute expressly states that local laws on a given subject matter are preempted. Preemption can also occur where the State Legislature has assumed full regulatory responsibility in a field related to the proposed local law.

Here, New York State Municipal Home Rule Law Section (NYSMHRL) 33 provides specific authority which permits counties to enact and amend county charters in order to establish and maintain a workable framework of government. Since the State Legislature has granted counties specific authority to enact local legislation on this topic, and the charter amendments contemplated by 8-1 do not fall within the limitations to such authority delineated in Section 34 of NYSMHRL, there is no preemption issue of concern.

Grammar

The stated purpose of 8-1 is to amend the Erie County Charter in order to create a Division of Consumer Protection within the Department of Public Advocacy which would be headed by a Director and to transfer the Erie County Division of Weights and Measures from the Department of Public Works to the newly created Division of Consumer Protection. We find the grammar and usage of 8-1 to be sufficient in order to achieve the stated purpose.

Ambiguities

While every hypothetical circumstance or eventuality cannot be addressed in the scope of this opinion, 8-1 does not present any facial ambiguities that would frustrate its implementation and enforcement.

Conclusion

We find that Local Law Intro. 8-1-2019 is sufficient as to form.
