1. COMM. 12E-17 (2006)

COUNTY EXECUTIVE

WHEREAS, Cloverbank Construction is the lowest responsible bidder for the General Construction Work; and

WHEREAS, no bids were received for the Electrical Construction Work; and

WHEREAS, your Honorable Body previously approved a General Architect/Engineer Agreement with the firm of Abate Associates to provide Engineering Services; and

WHEREAS, the Department of Public Works is requesting your Honorable Body's authorization to issue a change order to Abate Associates for providing constructioni services during the Construction Phase; and

WHEREAS, the Commissioner of Public Works has determined that constant supervision and inspection of the critical structural repairs being performed is required; and

WHEREAS, the Commissioner of Public Works is requesting approval to hire a Construction Inspector for the critical inspection work; and

WHEREAS, the County has sufficient funds for this work from a grant received from the Empire State Development Corporation.

NOW, THEREFORE, BE IT

RESOLVED, that the County of Erie be authorized to enter into an agreement with Cloverbank Construction. Inc. for the sum of \$207,000.00 and; be it further

RESOLVED, that the sum of \$60,000.00, which includes twenty-five percent (25%) of the General Construction Work and \$10,000 for General Construction Contractor to hire an electrical contractor, since no electrical bids were received, be allocated to a construction contingency fund with authorization for the Commissioner of Public Works to approve change orders in an amount not to exceed the contingency; and be it further

RESOLVED, that the Commissioner of Public Works be authorized to issue a change order to Abate Associates for an amount not to exceed \$15,000.00 for the Construction Administration Phase; and be it further

RESOLVED, that the County be authorized to hire a Construction Inspector to inspect the critical structural repairs for an amount not to exceed \$33,000.00; and be it further

RESOLVED, that the Comptroller be authorized to make payment for all the above in an amount not to exceed \$315,000.00, from SAP Project No. A.00234, '04 Botanical Gardens Master Plan; and be it further

RESOLVED, that two copies of this resolution be sent to the Department of Public Works, Office of the Commissioner, and one copy each to the Office of the County Executive, the Division of Budget, Management & Finance, and the Office of the Comptroller. (5-0)
