# ECONOMIC DEVELOPMENT COMMITTEE REPORT NO. 12

# ALL MEMBERS PRESENT. CHAIR MILLS PRESENT AS EX-OFFICIO MEMBER.

# 1. COMM. 12E-9 (2016)

# COUNTY EXECUTIVE

WHEREAS, Maple Road, form Hopkins Road to North Forest Road, experiences one of the highest traffic counts (23,100 ADT) for a County road and has one of the highest number of complaints concerning its condition; and

WHEREAS, the road consists of a concrete slab with an asphalt overlay which results in the concrete slab's expansion joints to cause reflective cracking through the asphalt wearing surface; and

WHEREAS, due to this type of road construction, a very rough surface had developed over a period of time; and

WHEREAS, the Department of Public Works is now scheduling to receive competitive bids by mid-August 2016 for the Maple Road Joint Rehabilitation Project, the "Project", and

WHEREAS, it is desired to amend an agreement with project designer Urban Engineers of NY DPC's to include design and construction phase engineering and inspection services.

NOW, THEREFORE, BE IT

RESOLVED, that funds from Fund 420, BA 123, SAP B.15019 - 2015 Capital Overlay Program Countywide in an amount not to exceed \$112,000 shall be made available for the Maple Road joint rehabilitation project for this phase; and be it further

RESOLVED, that the County Executive is authorized to issue a Contract Amendment for design and construction phase engineering and inspection services with project design engineer Urban Engineers of NY DPC; and be it further

RESOLVED, that the total cost of the Contract Amendment shall not exceed \$112,000.00 as follows:

Design (A/E Amendment A) \$ 54,000.00
Construction Phase Engineering & Inspection (A/E Amendment B) \$ 56,000.00
Misc. advertising, permits, etc. \$ 2,000.00

RESOLVED, that the Clerk of the Legislature forward three (3) certified copies of this resolution to the Department of Public Works, Office of the Commissioner, and also one copy each to the Office of the County Executive, the Division of Budget and Management and the Office of the Comptroller. # 2. COMM. 12E-10 (2016)

# **COUNTY EXECUTIVE**

WHEREAS, the Bridge Deck Sealing (20 Bridges) PIN 5761.32, (the "Project") is eligible for funding under Title 23, U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% Federal funds and 20% non-Federal funds, depending upon the Federal Aid Funding Program; and

WHEREAS, the County of Erie desires to advance the Construction phase of the Projects by making a commitment for the Federal and Non-Federal share of the costs of the project; and

WHEREAS, in order to facilitate the Construction and Construction Inspection Phases for the Projects, it will be necessary for the County to execute an Agreement with New York State Department of Transportation in the total amount of \$255,000 of which \$51,000 is the required local share, for the construction and construction phase of the Project; and

WHEREAS, the Department of Public Works would like to successfully implement the Project in a timely manner, it will be necessary for the County to execute the construction contract with the responsible low bidder, enter an into a construction phase engineering services agreement with CHA Consultants, and establish a construction contingency in an amount not to exceed \$255,000.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature hereby approves the Locally Administered Federal Aid Project for Bridge Deck Sealing NYS PIN 5761.32 Project; and be it further

RESOLVED, that the County Legislature of the County of Erie hereby authorizes the County of Erie to pay in the first instance 100% of Federal and non-Federal shares of the cost of Construction and Construction Inspection Phases of the Project or portions thereof; and be it further

RESOLVED, that the Project Fund B.14011, 2014 Bridge Preservation Programs, fund center 123, fund 420, be adjusted for the actual anticipated Federal revenue in the amount of \$204,000 as follows:

RESOLVED, that the estimated total sum of the construction and construction inspection Phase of the Project, \$255,000, is hereby appropriated from B.14011 – 2014 Bridge Preservation Programs and made available to cover the cost of participation in the Construction and Construction Inspection phase of the Project; and be it further

RESOLVED, the County Executive is hereby authorized to execute the construction contract with the responsible low bidder, enter an into a construction phase engineering services agreement with CHA Consultants, and establish a construction contingency in an amount not to exceed \$255,000; and be it further

RESOLVED, that in the event the amount required to pay in the first instance 100% of the Federal and non-Federal shares of the costs of the Project's construction and construction inspection phases exceeds the amount appropriated, \$255,000 the County of Erie shall convene its Legislature as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof; and be it further

RESOLVED, that the County Executive of the County of Erie is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid on behalf of the County of Erie, with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the Municipality's first instance funding of Project costs and permanent funding of the local share of Federal aid and State aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible; and be it further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation, by attaching it to any necessary Agreement in connection with the Project; and be it further

RESOLVED, that the Clerk of the Legislature forward six (6) certified copies of this Resolution to the Department of Public Works, Office of the Commissioner, to be forwarded to the New York State Department of Transportation; and be it further

RESOLVED, that the Clerk of the Legislature forward one (1) certified copies of this Resolution to the Department of Public Works, Office of the Commissioner, and also one copy each to the Office of the County Executive, the Division of Budget and Management and the Office of the Comptroller. # 3. COMM. 12E-11 (2016)

#### **COUNTY EXECUTIVE**

WHEREAS, The Town of Cheektowaga ("Town") intends to design and construct wheelchair ramps on several County owned roadways, including Cayuga Creek Road (CR 165) at Henry Street (TR), William Street (CR 207) near Girard Avenue (front of Roosevelt Elementary School), and Maryvale Drive (CR 199) near Kathleen Drive (Maryvale School access road); and
