ALL MEMBERS PRESENT. CHAIR MILLS PRESENT AS EX-OFFICIO MEMBER.

1. COMM. 8E-15 (2016) COUNTY EXECUTIVE

WHEREAS, group respite programs provide a safe, supervised, entertaining environment for memory impaired adults, thereby allowing their family caregivers temporary relief; and

WHEREAS, the Department of Senior Services is working to cost efficiently expand services for frail older adults in Erie County by partnering with faith-based and other local senior organizations to provide group respite programs; and

WHEREAS, partner institutions need assistance in setting up these programs; and

WHEREAS, the Department of Senior Services desires to extend the contract, previously approved in 6/25/15 COMM. 12E-13 with consultant, Ms. Lisa Rood, for the period April 1, 2016 through December 31, 2016 at a cost not to exceed \$5,000 to assist with the creation of additional group respite programs; and

WHEREAS, the Department of Senior Services has identified four additional area churches, Williamsville United Methodist Church, Kenmore United Methodist Church, Primera Iglesias Metodista Unida de Buffalo, and South Park United Methodist Church, as well as the Clarence Senior Center as interested in beginning this initiative; and

WHEREAS, the Department plans on providing each of the identified entities with a one time payment of \$1,000 to cover program start up expenses; and

WHEREAS, budgetary appropriations are available in the 163III-E2016 grant's Professional Services Contracts and Fees account to fund the contracts with the consultant and churches.

RESOLVED, that the County Executive be and is hereby authorized to extend the previously approved consultant contract with Lisa Rood, for the period April 1, 2016 through December, 31, 2016, at a cost not to exceed \$5,000 to assist with the expansion of the group respite program; and be it further
