LOCAL LAW NO. -2009

A Local Law in relation to reducing the size of the Erie County Legislature

Be it enacted by the Legislature of the County of Erie as follows:

- SECTION 1. LEGISLATIVE INTENT. It is the intent of the Legislature that the size of the Erie County Legislature be reduced from fifteen (15) members to nine (9) members to respond to the decline in the population of Erie County, recognize the proper number of legislators required to effectively carry out charter mandated duties and to reduce the costs of government for the taxpayers of Erie County. It is further the intent of the Legislature that this proposed change to the Erie County Charter be placed on the November, 2009 ballot as a referendum question. It is further the intent of the Legislature that the boundaries for the nine districts be determined in 2011 after the federal decennial census is taken in a manner consistent with Section 210 of the Erie County Charter.
- **SECTION** 2. Erie County Local Law number one of nineteen hundred fifty-nine, as amended, constituting the Erie County Charter, is hereby amended to read as follows:

Article 1 of the Erie County Charter is hereby amended to read as follows:

- Section 105. Legislative Districts. The County of Erie is hereby divided into fifteen nine districts, described as follows:
- Section 106. Legislative districts, continued. The seventeen fifteen legislative districts as previously bounded and described by Local Law No. 2 1991 Local Law No. 4-2002, shall continue as such for the limited purpose of continuing in office the legislators presently elected from said districts and shall cease to exist as such on January 1, 2004 2012. For the purpose of the general election of 2003 2011 and all other purposes, except as herein before provided, the county of Erie is divided into fifteen nine districts, as described as contained in section hundred five herein.

Article 2 of the Erie County Charter is hereby amended to read as follows:

- Section 201. County Legislature constituted. The county legislature shall be composed of fifteen nine members who shall be elected one from each of the fifteen nine districts set forth in section one hundred five hereof. The county legislators representing the fifteen nine districts heretofore or herein created, as the case may be, when lawfully convened shall constitute the county legislature which shall be the legislative and governing body of the county.
- **SECTION 3.** EFFECTIVE DATE. This Local Law shall take effect on January 1, 2012.

SECTION 4. SEVERABILITY. If any clause, sentence, paragraph, subdivision, section or part of this Local Law or the application thereof, to any person, individual, corporation, firm, partnership, entity or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional such order of judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this Local Law or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such judgment or order shall be rendered.

- Section 106. Legislative districts, continued. The seventeen fifteen legislative districts as previously bounded and described by Local Law No. 2 1991 Local Law No. 4-2002, shall continue as such for the limited purpose of continuing in office the legislators presently elected from said districts and shall cease to exist as such on January 1, 2004 2012. Article 2 of the Erie County Charter is hereby amended to read as follows:

- Section 201. County Legislature constituted. - Section 202.2 Election and terms of office. County legislators shall first be elected at the general election in the year nineteen hundred sixty-seven and shall assume office on January

first, nineteen hundred sixty-eight. All elected county legislators shall hold their respective offices for a term of two years.

SECTION 3. EFFECTIVE DATE. This Local Law shall take effect on January 1, 2012.

SECTION 4. SEVERABILITY. If any clause, sentence, paragraph, subdivision, section or part of this Local Law or the application thereof, to any person, individual, corporation, firm, partnership, entity or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional such order of judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this Local Law or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such judgment or order shall be rendered.

WHEREAS, the Erie County Sheriff's is responsible for the health care at the Erie County Correctional Facility and the Erie County Holding Center; and

WHEREAS, the Erie County Department of Health provides medical oversight and staff who provide health care at the Erie County Correctional Facility and Erie County Holding Center under an Interdepartmental Agreement with the Erie County Sheriff; and

WHEREAS, in 2008 a task force was formed to review the provision of health and mental health care in the two facilities overseen by the Sheriff; and

WHEREAS, in 2008 the Sheriff's Office, the Department of Law, the Departments of Health and Mental Health requested that the National Commission of Correctional Health Care provide technical assistance regarding health services at the facilities. Using national accepted standards, the purpose was to assess the state of health service delivery and make recommendations for improvement. This undertaking was funded by a grant from the New York State Division of Criminal Justice Services; and

WHEREAS, as a result of this assessment a comprehensive plan was prepared which included specific steps to be taken to correct deficiencies outlined in the report of the National Commission of Correctional Health; and

WHEREAS, the comprehensive plan included transitioning medical aide positions to registered nurse positions as they become vacant; and

WHEREAS, in order to efficiently meet program mandates it is necessary to implement staffing adjustments as outlined in the comprehensive plan by creating four full-time and two regular part-time positions of Registered Nurse, JG N-1 as indicated on B100 #5334 and deleting four

vacant full-time positions of Holding Center Medical Aide, JG 7, and two vacant part-time positions of Registered Nurse HC, JG N-1, as indicated on B100 # 5334; and

WHEREAS, sufficient funds are available within the Division to fully fund this request.

RE: Suicide at EC Holding Center

(INTRO 4-10, 2010)

WHEREAS, the recent suicide of a young inmate using shoelaces at the Erie County Holding Center has raised additional serious concerns about conditions inside the facility; and

WHEREAS, conditions at the Erie County Holding Center are already under serious scrutiny by both federal and state officials; and

WHEREAS, the Erie County Holding Center has had five suicides by hanging since 2007 and eight since 2003; and

WHEREAS, federal officials have indicated that the suicide rate in the Erie County facility is nearly five times the national average; and

WHEREAS, rates are further exacerbated if one includes the rate of attempted suicide; and

WHEREAS, Erie County was warned about how the Holding Center's poor design increases the likelihood of suicide in 2008 when the National Commission on Correctional Health Care noted that nooses can be tied to beds, loosened wall plates or bars on windows; and

WHEREAS, conditions at the Holding Center are clearly a matter of life and death.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature call upon the Sheriff and the County Attorney to immediately develop a written policy whereby shoelaces are not available to inmates at the Holding Center or simply enforce an existing policy, if there is one; and be it further

RESOLVED, that said policy be filed with the clerk of the Legislature within seven days; and be it further

RESOLVED, that the Sheriff and the County Attorney come before the Legislature's Public Safety Committee to discuss how the county is addressing the warnings provided by the National Commission on Correctional Health Care; and be it further

RESOLVED, that certified copies of this resolution be sent to the Sheriff, the County Attorney, the Comptroller, the NYS Commission on Corrections, and the Department of Justice.

WHEREAS, the County Executive submitted an efficiency grant application for the purpose of funding retroactive bonus payments of up to \$4,000 per AFSCME member to achieve productivity, holiday and healthcare savings for the county; and

WHEREAS, the ECFSA Finance Committee met on November 30, 2009 to discuss the AFSCME efficiency grant application; and

WHEREAS, on November 30, 2009, the ECFSA Finance Committee voted unanimously to recommend to the ECFSA Board that efficiency grant funding be made available to the County to be used to fund the county, library and college share \$2,449,077 of the \$2,918,074 application.
