WNY Businesses (INTRO 10-1)

A RESOLUTION TO BE SUBMITTED

BY LEGISLATORS KOZUB, MILLER-WILLIAMS, WHYTE, GRANT & MARINELLI

WHEREAS, the New York State Power for Jobs program has been successful in attracting businesses to Western New York with the incentive of low cost power or rebates on their electricity costs; and

WHEREAS, a portion of the electricity produced under the Power for Jobs program is generated at Niagara Falls; and

WHEREAS, the New York State Legislature and the Governor are negotiating to replace the Power for Jobs program with a new incentive program that will assure long term contracts for manufacturers throughout the state that create jobs with the money saved on their energy costs; and

WHEREAS, the Power for Jobs program also previously saved consumers in Western New York a small amount on their home electricity bills and now that savings is being proposed to aid economic development by offering low cost power to create jobs in New York; and

WHEREAS, homeowners in Upstate New York will see a positive economic impact in the form of lower taxes because jobs are created under this program that will more than offset the credit they were previously receiving on their home energy bills; and

WHEREAS, the economic impact of offering low cost power to those businesses and industries that choose to locate in Western New York can be an important incentive to job creation in Erie County.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature urges the New York State Legislature and New York Governor David Paterson to extend the Power for Jobs program or its successor in such a way that the incentives given will encourage strong economic development in Erie County and Upstate New York; and be it further

RESOLVED, that copies of this certified resolution be sent to the members of the Western New York state delegation and Governor David Paterson.
