INTRO 8-12 (2009) KOZUB WHEREAS, Mittal Steel recently completed a dredging of Smokes Creek, which FEMA (Federal Emergency Management Agency) in collaboration with the New York State Department of Environmental Conservation, had included in flood zone maps and identified as having a potential flood risk for communities adjacent to Smokes Creek in Lackawanna; and

WHEREAS, this area has not flooded in recent memory, yet remains in the "100 Year Flood Zone" category, which causes undue extra insurance coverage and premium payments for homeowners and businesses in this part of Lackawanna; and

WHEREAS, the decades-long absence of flooding, paired with the completion of the dredging project, calls for immediate relief for the residents and businesses in the designated flood plain area from the onerous burden of these insurance premium costs; and

WHEREAS, draft preliminary maps establishing the federal flood zone for this region are expected to be completed by FEMA by year's end (2009).

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature call upon FEMA and the New York State Department of Environmental Conservation to immediately prioritize the removal of certain communities in Lackawanna from the 100 Year Flood Zone Map, as the absence of flooding and the dredging of Smokes Creek have rendered this designation archaic, onerous and costly to the residents and businesses of this area; and be it further

RESOLVED, that representatives of the NYS DEC and/or FEMA be invited to a future meeting of the Erie County Legislature's Energy & Environment Committee to explain the timeframe for the review, analysis and removal of communities in Lackawanna from the flood zone map; and be it further

RESOLUTION NO. 177-2009

RESOLUTION DELEGATING TO THE COUNTY COMPTROLLER THE POWERS TO AUTHORIZE THE ISSUANCE OF \$75,000,000 REVENUE ANTICIPATION NOTES OF THE COUNTY OF ERIE, NEW YORK, OR SO MUCH THEREOF AS MAY BE NECESSARY, IN ANTICIPATION OF THE RECEIPT OF CERTAIN REVENUES FOR THE FISCAL YEAR ENDING DECEMBER 31, 2009, AND TO PRESCRIBE THE TERMS, FORM AND CONTENTS, AND PROVIDE FOR THE SALE AND CREDIT ENHANCEMENT OF SUCH NOTES.

RESOLVED BY THE LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

Section 1. Pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), the power to authorize the issuance of Revenue Anticipation Notes (herein called "Notes") of the County of Erie, in the State of New York (the "County" and "State", respectively), in the aggregate principal amount of not to exceed \$75,000,000, and any notes in renewal thereof, is hereby delegated to the County Comptroller, as chief fiscal officer of the County.

Section 2. The Notes shall be issued in anticipation of the collection or receipt of revenues due to the County in the 2009 fiscal year from (i) State Social Services aid, (ii) Social Services aid from the United States government, and (iii) the collection or receipt of revenues due and payable to the County in the 2009 fiscal year from sales and compensating use taxes; and the proceeds of such Notes shall be used only for the purposes of paying the current expenses of the County for said fiscal year payable from the revenues in anticipation of which they are issued.

Section 3. The Notes shall contain the recital of validity prescribed by Section 52.00 of the Law and shall be general obligations of the County, and the faith and credit of the County shall be pledged to the punctual payment of the principal of and interest on the Notes and, unless the Notes are otherwise paid or payment provided for, an amount sufficient for such payment shall be inserted in the budget of the County and a tax sufficient to provide for the payment thereof shall be levied and collected.

Section 4. Subject to the provisions of this resolution and the Law, and pursuant to Sections 50.00, 56.00, 60.00, and 168.00 of the Law, inclusive, the powers to prescribe the terms, form and contents, and all other powers or duties pertaining or incidental to the sale and issuance of the Notes authorized pursuant hereto, or any renewals thereof, including the power to determine the respective amounts of Notes to be issued in anticipation of said respective revenues specified in Section 2 hereof, and the power to enter into agreements for credit enhancement for the Notes, are hereby delegated to the Comptroller, as chief fiscal officer of the County.

Section 5. This resolution shall take effect immediately.

WHEREAS, the Erie County District Attorney's Office maintains its City Court and Domestic Violence bureaus on a portion of the 4<sup>th</sup> floor of the Buffalo City Court Building located at 50 Delaware; and whereas this office space is in serious need of renovations and new furniture due to significant disrepair and an overall unsafe working environment; and

WHEREAS, the District Attorney's Office will be contracting with various vendors and/or County departments for painting; minor carpentry; carpeting; new computer and telephone wiring; and moving costs; and

WHEREAS, the District Attorney's Office has received furniture cost estimates from a state and county approved vendor to furnish the office space as current furnishings and cubicles in the office are extremely outdated, mismatched and in significant disrepair; thus necessitating the need to purchase new modular and office furniture for that space; and

WHEREAS, vehicles are used by the District Attorney's Office for investigative, surveillance and prosecutorial purposes on a daily basis; however, two of the vehicles currently maintained by said office have mileage exceeding 100,000 miles and are simply no longer safe to drive; and

WHEREAS, the source of funds for the above mentioned projects will be paid from the District Attorney's asset forfeiture proceeds, and it is necessary to transfer funds from the Erie County District Attorney's Asset Forfeiture Trust Fund prior to their being expended.

NOW, THEREFORE, BE IT
