RESOLUTION DELEGATING TO THE COUNTY COMPTROLLER THE POWERS TO AUTHORIZE THE ISSUANCE OF \$65,000,000 REVENUE ANTICIPATION NOTES OF THE COUNTY OF ERIE, NEW YORK, OR SO MUCH THEREOF AS MAY BE NECESSARY, IN ANTICIPATION OF THE RECEIPT OF CERTAIN REVENUES FOR THE FISCAL YEAR ENDING DECEMBER 31, 2010, AND TO PRESCRIBE THE TERMS, FORM AND CONTENTS, AND PROVIDE FOR THE SALE AND CREDIT ENHANCEMENT OF SUCH NOTES. RESOLVED BY THE LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

Section 1. Pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), the power to authorize the issuance of Revenue Anticipation Notes (herein called "Notes") of the County of Erie, in the State of New York (the "County" and "State", respectively), in the aggregate principal amount of not to exceed \$65,000,000, and any notes in renewal thereof, is hereby delegated to the County Comptroller, as chief fiscal officer of the County.

Section 2. The Notes shall be issued in anticipation of the collection or receipt of revenues due to the County in the 2010 fiscal year from (i) State Social Services aid, (ii) Social Services aid from the United States government, and (iii) the collection or receipt of revenues due and payable to the County in the 2010 fiscal year from sales and compensating use taxes; and the proceeds of such Notes shall be used only for the purposes of paying the current expenses of the County for said fiscal year payable from the revenues in anticipation of which they are issued.

Section 3. The Notes shall contain the recital of validity prescribed by Section 52.00 of the Law and shall be general obligations of the County, and the faith and credit of the County shall be pledged to the punctual payment of the principal of and interest on the Notes and, unless the Notes are otherwise paid or payment provided for, an amount sufficient for such payment shall be inserted in the budget of the County and a tax sufficient to provide for the payment thereof shall be levied and collected.

Section 4. Subject to the provisions of this resolution and the Law, and pursuant to Sections 50.00, 56.00, 60.00, and 168.00 of the Law, inclusive, the powers to prescribe the terms, form and contents, and all other powers or duties pertaining or incidental to the sale and issuance of the Notes authorized pursuant hereto, or any renewals thereof, including the power to determine the respective amounts of Notes to be issued in anticipation of said respective revenues specified in

Section 2 hereof, and the power to enter into agreements for credit enhancement for the Notes, are hereby delegated to the Comptroller, as chief fiscal officer of the County.

Section 5. This resolution shall take effect immediately.

(ARRA) (INTRO 13-2)

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS MILLER-WILLIAMS, MILLS, BOVE & MARINELLI

WHEREAS, Medicaid is a federal, state and local health care program whose costs and administration represents the largest component of the state and local fiscal relationship in New York, currently totaling over \$51 billion annually; and

WHEREAS, since the program's inception, counties across the state have struggled to fund the growth of the Medicaid local share and even with local budget austerity measures the program's cost have resulted in higher property taxes, higher sales taxes, and a decline in county services; and

WHEREAS, while a local government Medicaid "cap" has been implemented in New York in an effort to provide some budget stability and help shield local taxpayers from the impact of

excessive Medicaid growth, counties remain concerned with the future sustainability of the Medicaid program, the effect on other state and local budget priorities, and the overall outlook for New York's economic competitiveness; and

WHEREAS, Congress has provided an increase in Federal Medicaid matching funds, set to expire on December 31, 2010, to all states under the American Recovery and Reinvestment Act in recognition of the recent fiscal crisis; and

WHEREAS, in addition to providing fiscal relief to the State of New York, this increase also provides direct fiscal relief to local governments in New York State which helps ease the local property and sales tax burdens for all New Yorkers; and

WHEREAS, the U.S. Senate, House and the President all support a six-month extension of this critical temporary enhanced Medicaid assistance through June 30, 2011 because of the continued fiscal pressures experienced by state and local governments due to further declines in tax revenues and increased demand for public services stemming from the recession; and

WHEREAS, New York and twenty-three other states have included a six-month extension of this enhanced funding in their budgets for the coming year, it is imperative that Congress enact a six-month extension of enhanced Medicaid assistance payments as soon as possible, to allow states to finalize their budgets without having to fill even larger budget holes with tax increases or service cuts that would be necessary in the absence of this federal funding.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature goes on record as strongly supporting a six-month extension of the enhanced Federal Medical Assistance Percentage (FMAP) as established under the American Recovery and Reinvestment Act (ARRA), and be it further

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS KOZUB, MILLS, BOVE, MARINELLI & DIXON

WHEREAS, Erie County Emergency Services has secured funding through the Public Safety Interoperable Communications Grant to construct a new 400mhz infrastructure for radio communications between firefighters and first responders; and

WHEREAS, while Erie County is funding the infrastructure, volunteer fire departments will be responsible for the purchase and maintenance of equipment that can be used on the new 400mhz communications system; and

WHEREAS, a total of 10 volunteer fire departments in the Orchard Park Fire District and the Angola Fire Control have applied for a 2010 AFG Regional Communications Grant with the federal government; and

WHEREAS, the grant applications request \$208,216 for the Orchard Park Fire District and \$630,761 for the Angola Fire Control, in funding to purchase interoperable and standardized radio equipment, specifically 400mhz digital capable mobile radios, portable radios and pagers; and

WHEREAS, the purchase of this equipment will be used to improve communications among the 490 active volunteer firefighters and first responders in the Orchard Park and Angola Fire Control; and

WHEREAS, this equipment will bring the partner agencies into statutory compliance with FCC P25 narrow-banding requirements; and

WHEREAS, these organizations protect an area comprising 103 square miles of suburban and rural communities in Erie County; and

WHEREAS, target hazards in the area served by the Orchard Park Fire District include a suburban community with rural areas, a 1200 acre County Park and an NFL stadium and in the Angola Fire Control there are major transportation lines including the New York State Thruway (I-90), two NY State Roads (NYS Route 5 and U.S. Route 20) and 15 miles of CSX and Norfolk rail lines that transport various materials including fuel, lumber and chemicals; and

WHEREAS, the organizations applying for the grants do not have the resources to purchase this 400mhz radio equipment.

NOW, THEREFORE, BE IT
