3. INTRO 5-2 (2010)

KENNEDY, MILLER-WILLIAMS, AS AMENDED

BOVE & MARINELLI

WHEREAS, the County of Erie (the "County") recognizes and respects the Seneca Nation of Indians (the "Nation") as an independent and sovereign nation, recognized by treaties entered into with the United States government such as the Treaty of Canandaigua of 1794 and the Treaty of Buffalo Creek of 1842; and

WHEREAS, the County recognizes that the 1794 Treaty recognizes the Nation's inherent right to the "free use and enjoyment" of its lands and that the 1842 Treaty precludes the application on Nation lands of "all taxes, and assessments for roads, highways, or any other purpose"; and

WHEREAS, the Nation has two territories located within the County of Erie, including the Cattaraugus Territory and the Buffalo Creek Territory, which are occupied by thousands of Senecas and hundreds of Nation-owned and privately-owned businesses; and

WHEREAS, the Nation has contributed greatly to the economy of Western New York, employing over 6,000 people, generating \$1.1 billion in economic impact in 2007, and playing an important role in the economic development of the region; and

WHEREAS, the Nation as a distinct society of indigenous people have contributed greatly to the cultural heritage of Western New York; and

WHEREAS, the Nation and the County have in the recent past developed and maintained a respectful relationship, and that the County seeks to maintain that relationship into the future; and

WHEREAS, the State of New York and the Nation are currently at odds over several issues, including the imposition of State taxes on commerce taking place on the Nation's territories; and

WHEREAS, given the Nation's sovereignty and its recognition by federal laws and treaties, the State must respect the Nation's sovereignty and treaty rights and cease and desist from taking any measures to impose its taxes on commerce taking place within the Nation's territories now or in the future.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature calls for New York State to acknowledge and abide by the treaties recognizing and protecting the sovereign rights of the Seneca Nation of Indians that are currently in place; and be it further

RESOLVED, that this Legislative Body believes that said treaties preclude the application of any New York State taxes within the Nation's territories for any purpose whatsoever; and be it further

RESOLVED, that this Legislative Body believes that a process of negotiation and open dialogue between the State of New York and the Seneca Nation of Indians should be employed to address outstanding disputes; and be it further

RESOLVED, that copies of the resolution be forwarded to Governor Paterson, the State Senate and Assembly Finance Committees, the State Department of Taxation and Finance, and the Seneca Nation of Indians.

4. COMM. 11E-7 (2010)

COUNTY EXECUTIVE

WHEREAS, Erie County formed a Consortium (Erie County HOME Consortium) with the Towns of West Seneca and Hamburg for the purpose of obtaining funding under the HOME Investment Partnership Act (HOME); and

WHEREAS, the Erie County HOME Consortium has been awarded a HOME grant of \$1,195,159 for fiscal year 2009 and \$1,192,338 for fiscal year 2010 by the U. S. Department of Housing and Urban Development; and

WHEREAS, a minimum of fifteen percent of said funds made available pursuant to the HOME Investment Partnership Act are to be provided to eligible Community Housing Development Organizations (CHDOs).

RESOLVED, that the County Executive, on behalf of the Erie County Community Development Block Grant and Town of Hamburg/Erie County HOME Consortia is hereby authorized to enter into all necessary agreements with New Opportunities (CHDO) to develop affordable rental housing for low-income households in the Village of Alden; and be it further

RESOLVED, that said agreement shall provide for the transfer of an amount not to exceed \$250,000 to New Opportunities; and be it further

RESOLVED, that disbursement of said funds shall be conditioned on the following:

- 1. Completion of all state and federal environmental review requirements relative to the housing projects.
- 2. Completion of all necessary subsidy layering analyses as required by the federal Department of Housing and Urban Development; and be it further

RESOLVED, that all Community Housing Development Corporations within the HOME Consortium were informed regarding the availability of HOME funds and a summary of the selection process is included as Attachment B to this resolution; and be it further

RESOLVED, that copies of this resolution shall be forwarded to the County Executive; the Commissioner of the Department of Environment and Planning; the County Comptroller; the County Attorney; and the Director of the Division of Budget and Management. (5-0)

5. COMM. 12E-20 (2010)

COUNTY EXECUTIVE

WHEREAS, the County of Erie, pursuant to Comm. 12E-11 dated July 12, 2007, relating to the control of snow and ice on County roads by towns and incorporated villages, entered into a two year agreement with local municipalities for such purposes; and

RESOLVED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

Section 1. The County of Erie, New York (herein called "County"), is hereby authorized to demolish various County-owned buildings at the Erie County Medical Center Corporation Grider Campus, including the costs of a demolition contractor and any sub contractors hired to deconstruct the buildings, remediate any necessary environmental hazards in said various buildings, relocate utilities, hauling and site remediation expenses; all pursuant to an agreement dated December 30, 2009 between the County and the Erie County Medical Center Corporation (the "ECMCC"). To the extent that the details set forth in this resolution are inconsistent with any details set forth in the 2010 Capital Budget of the County, such Budget shall be deemed and is hereby amended. The estimated maximum cost thereof, including preliminary costs and costs incidental thereto and the financing thereof, is \$3,250,000 and said amount is hereby appropriated therefor, including the expenditure of \$1,625,000 in funds expected to be paid by the ECMCC (the "ECMCC Funds"). The plan of financing for such specific object or purpose includes the expenditure of the \$1,625,000 ECMCC Funds and the issuance of \$1,625,000 bonds of the County to finance the balance of said appropriation and the levy and collection of taxes on all the taxable real property in the County to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

Section 2. Bonds of the County in the principal amount of \$1,625,000 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), to finance said appropriation.

Section 3. The period of probable usefulness of the class of objects or purposes for which said \$1,625,000 bonds herein authorized are to be issued, pursuant to Section 11.00 a. 12-a (b) of the Law, is ten (10) years.

Section 4. The County intends to finance and the Comptroller of the County is hereby authorized to advance such amounts as are necessary to pay the costs of the objects or purposes described in Section 1 hereof prior to the issuance of the bonds or bond anticipation notes authorized out of any available funds of the County, on an interim basis, which amounts are reasonably expected to be reimbursed with the proceeds of debt to be incurred by the County, pursuant to this Resolution, in the maximum amount of bonds herein authorized. This Resolution is a declaration of official intent adopted pursuant to the requirements of Treasury Regulation Section 1.150-2.

Section 5. Subject to the provisions of this Resolution and of the Law, and pursuant to the provisions of §21.00 relative to the issuance of bonds having substantially level or declining debt service, §30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals thereof, and of §\$50.00, 56.00 to 60.00 and 168.00 of said Law, the powers and duties of the County Legislature relative to authorizing the issuance of any notes in anticipation of the sale of the respective amounts of bonds herein authorized, or the renewals thereof, relative to providing for substantially level or declining annual debt service, relative to prescribing the terms, form and contents and as to the sale and issuance of the respective amounts of bonds herein authorized, and of any notes issued in anticipation of the sale of said bonds or the renewals of said notes, and

relative to executing agreements for credit enhancement, are hereby delegated to the Comptroller of the County, as the chief fiscal officer of the County.

Section 6. Each of the bonds authorized by this Resolution and any bond anticipation notes issued in anticipation of the sale thereof shall contain the recital of validity prescribed by §52.00 of said Local Finance Law and said bonds and any notes issued in anticipation of said bonds shall be general obligations of the County of Erie, payable as to both principal and interest by general tax upon all the taxable real property within the County without limitation as to rate or amount.
