A LOCAL LAW PROVIDING FOR THE LEASE OF A PORTION OF THE SOUTH CAMPUS OF ERIE COMMUNITY COLLEGE FOR THE DEVELOPMENT OF STUDENT HOUSING

BE IT ENACTED by the Erie County Legislature as follows:

SECTION 1. Notwithstanding the provisions of Section 215 of the County Law or any special act or local law to the contrary, the County may lease such portion of the South Campus of Erie Community College, as may be determined by the Erie County Legislature to not be required for public use, to the Erie Community College Foundation or an affiliated 501(c)(3) entity for the development of student housing on the South Campus of Erie Community College, without competitive bidding or public advertisement, on such terms and conditions as may be approved by the Erie County Legislature. Such lease may provide for an original term of up to thirty-five years and for a total term, including renewals and extensions, of up to forty-nine years.

<u>SECTION 2.</u> If any article, section, subsection, paragraph, phrase or sentence of this local law is for any reason held invalid or unconstitutional by any court of competent jurisdiction, that portion shall be deemed a separate distinct, and independent provision and such holding shall not affect the validity of the remaining portion hereof.

<u>SECTION 3.</u> This local law shall take effect immediately in accordance with Section 27 of the New York State Municipal Home Rule Law.

#### **COUNTY EXECUTIVE**

WHEREAS, the Erie County Legislature has already appropriated funds for the Community Services for the Elderly (CSE), Community Services Initiative (CSI), Health Insurance Information Counseling and Assistance Program (HIICAP) and Long Term Care Ombudsman Program (LTCOP) grants for the period April 1, 2006 to March 31, 2007; and for the Title V Senior Employment Program grant for the period July 1, 2006 to June 30, 2007, and

WHEREAS, the New York State Office for the Aging has notified the Department of Senior Services (Department) that the Department has been awarded additional funds for HIICAP, LTCOP and the Senior Employment programs, and

WHEREAS, the Department also received the insurance proceeds for a van, originally purchased with CSI grant funds, which was destroyed in a fire, and

WHEREAS, the Department is obligated to use these insurance proceeds to replace the van originally purchased with CSI funds, or to remit 75% of the proceeds to the grantor, and

WHEREAS, the Department desires to use these insurance proceeds, along with designated funds in cost center 1632020, to replace the van to ensure that the existing fleet operated by the many community agencies and municipalities remains in good-working order, and

WHEREAS, the Department currently contracts with the American Red Cross - Greater Buffalo Chapter to provide ombudsman services under the LTCOP grant, and Supportive Services ,Inc. to provide Title V employment services under the Senior Employment grant, and

WHEREAS, the Department currently contracts with the American Red Cross - Greater Buffalo Chapter, Hispanics United of Buffalo, Lt. Col. Matt Urban Human Services Center, Northwest Buffalo Community Center, Inc., Old First Ward Community Association, Inc., Schiller Park Community Services, Inc. and West Side Community Services to provide transportation services to the elderly through December 31, 2006, and

WHEREAS, the Department desires to extend the terms of the transportation contracts with these community-based agencies through March 31, 2007, the end of the CSE grant period, and

WHEREAS, the State Pharmaceutical Assistance Program (SPAP) grant will end September 30, 2006 and the Department has identified the continuing need to counsel seniors and upcoming seniors on pharmaceutical and long term care insurance options available to them, and

WHEREAS, Legal Services for the Elderly, Disabled or Disadvantaged of Western New York, Inc. has been providing legal assistance to seniors denied or unable to obtain creditable coverage for prescription drugs from March through September, 2006 under SPAP, and

WHEREAS, the new Medicare enrollment period starting November 15, 2006 is expected to be problematic for low income seniors needing prescription coverage, and

WHEREAS, the Department desires to contract with Legal Services for the Elderly to provide legal assistance to seniors denied or unable to obtain creditable coverage for prescription drugs, effective October 1, 2006 through March 31, 2007, under the HIICAP grant, and

WHEREAS, the Department has reviewed its service objectives and vacant positions as a result of recent retirements and desires to transfer one position from a grant that is ending to a grant that can support such activity; to delete two positions (one County-funded and the other grant funded) and create one grant funded position that absorbs key functions of the department, thereby maximizing grant reimbursements and creating overall departmental cost and operational efficiencies; and to replace a position with one that is more encompassing in project management, and

WHEREAS, the Department desires to transfer the Coordinator of Insurance Outreach and Education position (no. 51001877) from the SPAP grant to the CSE grant; to delete the SPAP-funded Coordinator of Community Partnership Development position (no. 51003077), the County-funded Secretary to the Commissioner position (no. 51001121), the CSE-funded Account Clerk Typist position (no. 00000087) and the Senior Contract Monitor position (no. 00008708), effective October 1, 2006; and to create a CSE-funded Administrative Clerk position and a III-B-funded Project Administrator-Senior Services position, all effective October 1, 2006, and

WHEREAS, these position changes are reflected in the SAP system on B-100 position authorization forms, Control numbers 2308, 2332, 2334, 2335 and 2362, and

WHEREAS, the CSE, CSI, HIICAP, LTCOP and Senior Employment grant budgets need to be revised, and

WHEREAS, sufficient funds are available in the III-B grant, and

WHEREAS, local match is either not required or is sufficient to cover the revised grant allocations and revisions, and

WHEREAS, the County will generate a \$16,100 savings in the operating fund for 2006 as a result of the above position changes.

WHEREAS, the balance of the 2007 cost of these positions will be included in the 2007 budget.

WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 5-A of the County Law, a report of the Erie County Sewer Agency dated May 3, 2006 and a resolution of the Erie County Sewer District No. 3 Board of Managers dated June 14, 2006, an extension of Sewer District No. 3 of the County of Erie, New York has been proposed; and

WHEREAS, a map and plan have been duly prepared by the County Engineers (Erie County Department of Environment and Planning) relating to such extension of the Erie County Sewer District No. 3, which map and plan have been filed with the County Legislature pursuant to Section 254 of the County Law; and

WHEREAS, said map, plan, report and estimate of cost contains (i) a description of the proposed boundaries of the area which the Department in its judgment considers will be benefited by the Proposed Sewer District, (ii) a description of the areas of the Proposed Sewer District to permit definite and conclusive identification of all parcels of property included therein, (iii) the proposed location of facilities of the Proposed Sewer District, and (iv) estimates of the cost of construction, reconstruction, if any, or procurement and installation of facilities, all as more fully described in the map, plan, report and estimate of cost hereinbefore referred to; and

WHEREAS, there will be no additional capital costs incurred by or on behalf of the Erie County Sewer District No. 3 with respect to the extension of the boundaries of such District and the acquisition of the existing facilities, but future annual charges will be apportioned between real property in the District in accordance with their respective proportionate shares in accordance applicable flat charges, hook-up charges and charges based on units, assessed value and footage, specified in the District's Benefit and User Charge formulas, as such formulas currently exist and as amended from time to time; and

WHEREAS, hook up fees are \$250 per home for a lateral inspections of individual connections to existing county-built sewers, \$250 per home for inspections associated with subdivisions or other privately built sewers and a \$2 permit fee at the time of connection, and new homes or businesses will be charged a one-time equity fee of \$1,100 for connecting to existing sewers; and

WHEREAS, pursuant to Section 258 of the County Law, as amended by Chapter 397 of the Laws of 1995, the consent of the State Comptroller is not required prior to the establishment of the extension of the District because the cost thereof to the Typical Property (as defined in the County Law) does not exceed the Average Estimated Cost to the Typical Properties for similar types of expenditures, as computed by the State Comptroller and such cost is \$276.00; and

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

Section 1. Upon the evidence given at the public hearing held on August 3, 2006, and after due consideration of the map and plan, and other recommendations and other data, if any, heretofore provided to the County Legislature, it is hereby found and determined that:

- (a) the proposed extension is satisfactory, sufficient, adequate and appropriate;
- (b) all the property and property owners within the proposed extension are benefited thereby;
- (c) all the property and property owners benefited are included within the limits of the proposed extension;
- (d) it is in the public interest to extend said Erie County Sewer District No. 3.

Section 2. The extension of Erie County Sewer District No. 3 is hereby approved and said extension shall comprise an area described as follows:

#### Hamburg Sewer District 7

WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 5-A of the County Law, including approving orders of the State Comptroller, County Sewer District No. 4 of the County of Erie, New York, has heretofore been established and created on February 21, 1961 (the "Original District") to provide sewer services to the Town of Lancaster, and

WHEREAS, in 1983, the Original District was extended to include the Village of Depew; and

WHEREAS, in 2002 an extension to the Original District known as the Walden Corridor Extension was formed to provide sewer service to the Lancaster Sewer District Nos. 6, 7, and 8 along with the area bounded by the centerline of Peppermint Road, the north border of the adjacent CSX railroad property, the previous eastern boundary of the Original District and the centerline of Townline Road; and

WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 5-A of the County Law, a report of the Erie County Sewer Agency dated May 8, 2006 and a resolution of the Erie County Sewer District No. 4 Board of Managers dated June 21, 2006, an extension to the District has been proposed; and

WHEREAS, hook up fees are \$250 per home for a lateral inspections of individual connections to existing county-built sewers, \$250 per home for inspections associated with subdivisions or other privately built sewers and a \$2 permit fee at the time of connection, and new homes or businesses will be charged a one-time equity fee of \$1,100 for connecting to existing sewers; and

WHEREAS, pursuant to Section 258 of the County Law, as amended by Chapter 397 of the Laws of 1995, the consent of the State Comptroller is not required prior to the establishment of the extension of the District because the cost thereof to the Typical Property (as defined in the County Law) does not exceed the Average Estimated Cost to the Typical Properties for similar types of expenditures, as computed by the State Comptroller and such cost is \$302.32; and

WHEREAS, pursuant to proceedings heretofore had and taken a report of the Erie County Sewer Agency dated May 8, 2006, a resolution of the Erie County Sewer District No. 4 Board of Managers dated June 21, 2006, and pursuant to Section 274-b of the County Law, a consolidation of the District has been proposed; and

WHEREAS, said County Legislature duly adopted Resolution No. 199 on the 13<sup>th</sup> day of July, 2006, calling a meeting of the County Legislature for the purpose of holding a public hearing on (i) the aforesaid extension of Erie County Sewer District No. 4 in accordance with the aforesaid map and plan dated May 8, 2006, and (ii) the consolidation of Erie County Sewer District No. 4 in accordance with the aforesaid map and plan dated May 8, 2006, and

WHEREAS, the Erie County Sewer District No. 4 Board of Managers and the County Legislature have given due consideration to the impact that the extension and consolidation of Erie County Sewer District No. 4 may have on the environment and on the basis of such consideration, have found that no substantial adverse environmental impact will be caused thereby; and

WHEREAS, the Erie County Sewer District No. 4 Board of Managers and the County Legislature have complied in every respect with all applicable federal, state and local laws and regulations regarding environmental matters including compliance with the New York State Environmental Quality Review Act, comprising Article 8 of the Environmental Conservation Law and, in connection therewith; and

WHEREAS, said public hearing was duly held at 92 Franklin Street, 4<sup>th</sup> Floor, Buffalo, New York, in said County, on the 3<sup>rd</sup> day of August, 2006, at 1:30 o'clock P.M., Prevailing Time; and

WHEREAS, notice of said public hearing was duly published in the manner provided by law and proof thereof was submitted to said County Legislature; and

WHEREAS, said County Legislature has duly considered the evidence given at such public hearing.

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

Section 1. WITH RESPECT TO THE EXTENSION OF THE DISTRICT, and upon the evidence given at the public hearing held on August 3, 2006, and after due consideration of the map and plan, and other recommendations and other data, if any, heretofore provided to the County Legislature, it is hereby found and determined that:

Beginning at a point in the centerline of Walden Avenue, (formerly known as Ellicott Road), at its intersection with the west line of Sublot 1 as extended, Map Cover No. 470, thence east along the center line of Walden Avenue, a distance of 2,831.84 feet more or less, to a point, said point being 128.54 feet easterly from the east line of Seneca Place, (measured along the centerline of Walden Avenue), thence north along the centerline of Sublot 165, Cover Map No. 900, thence continued north along the east property lines of Sublots 169 and 243, thence west 1110 feet more or less, along the north line of Farm Lot 11, Section 8 and Farm Lot 1, Section 11 to a point, said point being the dividing lines between John Vrieson on the west and Leonard Dubiel on the east, thence north along the boundary line between said John Vrieson on the west and Leonard Dubiel on the east, to the south property line of lands owned by the Board of Education, Central District No. 1, Lancaster, Cheektowaga and Elma, thence east along the south line of said school lands to the east line of Farm Lot No. 2, thence north along the east line of Farm Lot No. 2, a distance of 900 feet, to a point, thence west across the said school lands to the center line of Central Avenue, thence south along the said center line to a point, said point being 522.80 feet north of centerline of Columbia Road, thence west 1,000 feet more or less, parallel to the centerline of Columbia Road and 522.80 feet distance therefrom to a point, being the northwest corner of lands owned by Henry S. Section 4. WITH RESPECT TO THE CONSOLIDATION, it is hereby determined that it is in the public interest to assess all expenses of Erie County Sewer District No. 4, including all extensions heretofore and hereafter established, as a charge against the entire area of Erie County Sewer District No. 4 as extended.

Section 5. This resolution is subject to permissive referendum and the Clerk of the Legislature is hereby authorized and directed to publish in full, within ten days after the adoption hereof, a Notice containing a true copy of this resolution, the resolution number, the date of adoption and a statement that such resolution is subject to permissive referendum. WHEREAS, On June 22, 2006, David Crane, President and Chief Executive Officer of NRG Energy, Inc. announced plans for a \$1.5 billion upgrade of the power plant located on the east shore of the Niagara River, off River Road, in the Town of Tonawanda, which aims to double generating output, secure and create good-paying jobs, and result in a much more clean and environmentally responsible operation; and

WHEREAS, The CR Huntley Station has a long history on its 120-acre site in Tonawanda, with some of its structures dating back to 1916 when "River Station" first began commercial service, and at one time was the largest coal-fired plant in the world during World War II; and

WHEREAS, The investment in CR Huntley will not only lead to a more cleaner-running and environmentally-friendly power plant, it also means a brighter and more secure future for the 131 people currently employed there, the creation of about 100 new positions, and also the creation of more than 1,000 construction jobs; and

WHEREAS, The upgrade includes the installation of modern emission control equipment on two CR Huntley units that have been problematic in controlling harmful pollutants, and will result in dramatic reductions in sulfur dioxide, nitrogen oxide, and mercury emissions, according to NRG officials; and

WHEREAS, A new power plant will also be constructed on the CR Huntley site, utilizing "Integrated Gasification Combined Cycle" (IGCC), a technology used to convert coal into combustible gas, with the resulting byproducts cleaned and resold for other industrial and construction uses; and

WHEREAS, When the new IGCC plant comes on line in 2012, combined with the existing two upgraded coal-fueled units, generating capacity will nearly double, from 552 megawatts today to 1,010 megawatts; and

WHEREAS, Moreover, adding to the positive local job outlook and environmental benefits, the new vision for the CR Huntley Station will mean more stable electricity prices, and perhaps a reduction, for Western New York residents, according to NRG Executive Vice President Curt Morgan, who said that with more "baseload generation" in New York State, the added megawatts will help to reduce the volatility in electric bills that have affected local consumers in recent years.

RESOLVED, That this Legislature respectfully requests that NRG seeks to optimize local economic development by maximizing the construction employment opportunities through an exemplary local construction trades workforce as well as economic development opportunities through local marketing of IGCC by-products; and be it further

RESOLVED, That this Legislature is strongly encouraged by the leadership of State and Federal officials, as well as members of Local #97 International Brotherhood of Electrical Workers Union, in coming together to advance this initiative; and be it further

RESOLVED, That this Legislature urges support for proposed federal tax credits from the Department of Energy, Empire Zone and other New York State incentives, as well as the selection of the upgraded plant by New York State as a designated clean coal power plant, further financially ensuring its viability; and be it further

RESOLVED, That certified copies of this resolution be forwarded to NRG Energy Inc., New York Governor George A. Pataki, the Western New York delegations to Congress and the New York State Legislature, the United States Department of Energy, and Erie County Executive Joel A. Giambra. (4-0)

# A RESOLUTION TO BE SUBMITTED BY LEGISLATOR SMITH

WHEREAS, one in three students across New York State does not graduate on time and in many communities the graduation rate is even lower; and

WHEREAS, New York State has the largest funding gap between high and low income school districts and one of the highest student achievement gaps; and

WHEREAS, as of 2004, 38% of 4<sup>th</sup> graders and 58% of 8<sup>th</sup> graders statewide failed the state English Language Arts test, and 21% of 4<sup>th</sup> graders and 42% of 8<sup>th</sup> graders failed the state Math test. In 2005, 36% of high school students did not graduate in 4 years, more than 1 in 10 dropped out: 13% of poor rural students; and

WHEREAS, high quality early learning experiences have been shown to have a wide range of positive effects on young children, including on school readiness, maturation and socialization, and later school performance. Despite this evidence, three-fourths of New York's 220,000 four-year olds do not have access to pre-kindergarten; and

WHEREAS, smaller class sizes improve student performance, by permitting more individualized instruction yet, average kindergarten class size in the "Big 4" (Buffalo, Rochester, Syracuse and Yonkers) actually increased in the 1999-2000 to 2003-2004 period, even though a limited state program had been put into place to reduce early grade class size; and

WHEREAS, the New York State Court of Appeals has ruled, in the campaign for Fiscal Equity case, that the State of New York is failing in its constitutional obligation to provide all of New York's public school students in New York City with access to a Meaningful high school education, also known as "sound basic education;" and

WHEREAS, the Court of Appeals specified significant increases in school funding are necessary to provide a meaningful high school education or sound basic education; and

WHEREAS, increased education funding, invested in proven educational strategies with clear accountability provision is a sound strategy to increase educational outcomes; and

WHEREAS, the proportion of total school funding in New York provided by the state government is at its lowest level in fifty years and there is a tremendous need to provide additional school funding through increased state aid rather than increased local taxes; and

WHEREAS, the Erie County Legislature wishes to show support for a statewide resolution of the Campaign for Fiscal Equity case that includes a fairer state aid provided to local schools based upon student need combined with accountability to ensure educational results.

RESOLVED, that the Erie County Legislature declares September 2006 Act for Education Month in Erie County, to encourage a statewide solution to the Fiscal Equity case.

BOND RESOLUTION DATED SEPTEMBER 28, 2006

BOND RESOLUTION OF THE COUNTY OF ERIE, NEW YORK, AUTHORIZING RECREATIONAL AREA IMPROVEMENTS TO THE BUFFALO ZOO, STATING THE ESTIMATED TOTAL COST THEREOF IS \$16,000,000, APPROPRIATING \$4,000,000 THEREFOR, AUTHORIZING THE ISSUANCE OF \$4,000,000 BONDS OF THE COUNTY TO PAY THE COST THEREOF AND THE APPLICATION OF \$6,750,000 EXPECTED TO BE RECEIVED FROM THE STATE OF NEW YORK AND \$5,250,000 EXPECTED TO BE RECEIVED FROM PRIVATE SOURCES TO BE EXPENDED TOWARDS THE COST THEREOF OR REDEMPTION OF THE BONDS ISSUED THEREFOR OR TO BE BUDGETED AS AN OFFSET TO THE TAXES FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON SAID BONDS.

(Introduced) SEPTEMBER 12, 2006

(Adopted) SEPTEMBER 28, 2006

RESOLVED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK, AS FOLLOWS:

Section 1. The County of Erie, New York (herein called "County") is hereby authorized to finance recreational area improvements to the Buffalo Zoo, including construction of a new South American Rainforest and Greenhouse exhibit as more fully described in the duly adopted 2006 Capital Budget for the County and pursuant to agreements with the City of Buffalo and the Zoological Society of Buffalo. To the extent that the details set forth in this resolution are inconsistent with any details set forth in the 2006 Capital Budget of the County, such Budget shall be deemed and is hereby amended. The total estimated maximum cost of said specific object or purpose, including preliminary costs and costs incidental thereto and to the financing thereof, is \$16,000,000, and \$4,000,000 is hereby appropriated therefor pursuant to the duly adopted Capital Budget of said County for fiscal year 2006. The plan of financing includes the issuance of \$4,000,000 bonds herein authorized and any bond anticipation notes issued in anticipation of the sale of such bonds, the levy of a tax to pay the principal of and interest on said bonds and notes and application of \$6,750,000 expected to be received from the State of New York and \$5,250,000 expected to be received from private sources to be expended towards the cost thereof or redemption of the bonds or notes issued therefor or to be budgeted as an offset to the taxes for the payment of principal of and interest on said bonds or notes.

Section 2. Bonds of the County in the principal amount of \$4,000,000 are hereby authorized to be issued for the specific object or purpose described in Section 1, pursuant to the

provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), to finance said appropriation.

Section 3. The period of probable usefulness for the specific object or purpose for which said \$4,000,000 bonds herein authorized are to be issued, within the limitations of \$11.00 a. 19.(c) of the Law, is fifteen (15) years.

Section 4. The County intends to finance and the Comptroller of the County is hereby authorized to advance such amounts as are necessary to pay the costs of the object or purpose described in Section 1 hereof prior to the issuance of the bonds or bond anticipation notes authorized out of any available funds of the County, on an interim basis, which amounts are reasonably expected to be reimbursed with the proceeds of debt to be incurred by the County, pursuant to this Resolution, in the maximum amount of bonds herein authorized. This Resolution is a declaration of official intent adopted pursuant to the requirements of Treasury Regulation Section 1.150-2.

Section 5. Subject to the provisions of this Resolution and of the Law, and pursuant to the provisions of §30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals thereof, and of §\$50.00, 56.00 to 60.00 and 168.00 of said Law, the powers and duties of the County Legislature relative to authorizing the issuance of any notes in anticipation of the sale of the respective amounts of bonds herein authorized, or the renewals thereof, relative to providing for substantially level or declining annual debt service, relative to prescribing the terms, form and contents and as to the sale and issuance of the respective amounts of bonds herein authorized, and of any notes issued in anticipation of the sale of said bonds or the renewals of said notes, and relative to executing agreements for credit enhancement, are hereby delegated to the Comptroller of the County, as the chief fiscal officer of the County.

Section 6. Each of the bonds authorized by this Resolution and any bond anticipation notes issued in anticipation of the sale thereof shall contain the recital of validity prescribed by \$52.00 of said Local Finance Law and said bonds and any notes issued in anticipation of said bonds shall be general obligations of the County of Erie, payable as to both principal and interest by general tax upon all the taxable real property within the County without limitation as to rate or amount. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds and any notes issued in anticipation of the sale of said bonds or the renewals of said notes, and provision shall be made annually in the budgets of the County by appropriation for (a) the amortization and redemption of the notes and bonds to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 7. The validity of the bonds authorized by this Resolution and of any notes issued in anticipation of the sale of said bonds may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money, or
- (b) the provisions of law which should be complied with at the date of the publication of this Resolution or a summary hereof, are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

(c) such obligations are authorized in violation of the provisions of the Constitution.

Section 8. This Resolution shall take effect immediately upon approval by the County Executive.

The Erie County Fiscal Stability Authority (ECFSA), as part of its mission, often publicly remarks on the status of the county's finances. One such remark, directed to the Erie County Legislature, was that the county needed to reduce its long term debt. In response to this statement the Erie County Legislature passed a resolution (Intro. 11-8) to reduce long term debt by placing a cap on borrowing. This resolution specifically resolved that the Legislature would not consider any bond resolution that would exceed 12 million dollars in borrowing in 2006. The Legislature has already approved bonds for capital expenditures up to that amount.

At our meeting on Thursday, September 28, 2006 the Legislature will be asked to consider voting for, or against, a bond resolution that would provide the Buffalo Zoological Society the necessary funding required for them to construct a new rainforest exhibit.
