WHEREAS, each county, city, town or village has the option of deciding whether to grant the Cold War veterans exemption; and

WHEREAS, the Erie County Legislature believes that it is appropriate to honor the service of Cold War veterans of Erie County by allowing them to take advantage of this limited exemption from real property taxes; and

(INTRO 19-7)

A RESOLUTION TO BE SUBMITTED BY LEGISLATORS MARINELLI, WHYTE, MAZUR, REYNOLDS, IANNELLO, GRANT, KENNEDY, LOUGHRAN & KOZUB

WHEREAS, childhood lead poisoning has been conclusively established by the Center for Disease Control as a cause of cognitive and developmental deficits including diminished intelligence, hyperactivity, oppositional behavior and speech delays and has been known to be a neurotoxin for at least 100 years; and

WHEREAS, it can be estimated that thousands of children residing in the County of Erie, within all legislative districts suffer from lead poisoning; and

WHEREAS, housing investigation case records for lead poisoning have indisputable administrative, fiscal, legal, and historical value; and

WHEREAS, such public records, documenting the presence or absence of lead in dwellings, are invaluable to potential renters or purchasers seeking to make informed decisions; and

WHEREAS, the County of Erie has recouped over \$300,000 in otherwise unrecoverable Medicaid liens as a result of lead poisoned children's recoveries for their damages through litigation; and

WHEREAS, the destruction of such records would prejudice the rights of numerous injured children in Erie County to seek legal compensation for their injuries; and

WHEREAS, the destruction of such records would cause the county significant future pecuniary loss, by preventing injured children from recouping the funds necessary to repay Medicaid liens related to their treatment; and

WHEREAS, the County of Erie is protected from lawsuits brought on behalf of lead poisoned children and their families by virtue of the ruling of the Court of Appeals of the State of New York in *Pelaez v. Seide*, 2 N.Y.3d 186 (2004), attached; and
