WHEREAS, nurse practitioners also refer patients to other health care providers without direct supervision; and

WHEREAS, many nurse practitioners are certified by national accrediting agencies in one or more practice specialties, beyond the certification they receive by New York State; and

WHEREAS, at present, a mandatory collaboration relationship between a nurse practitioner and medical doctor is required under New York State law; and

WHEREAS, legislation pending in the State Assembly and State Senate would update the practice of nurse practitioners to reflect the times and the need for primary health care access by individuals and families in underserved urban and rural areas of the state; and

WHEREAS, the following states allow such a practice, thereby acting as a magnet for individuals educated in New York State to instead serve communities in Arizona, Maine, Oregon, Alaska, the District of Columbia, Montana, New Hampshire, Utah, Washington State, Iowa and Wyoming; and

WHEREAS, mandatory collaboration no longer serves a clinical purpose, given the education, training and advanced certification of nurse practitioners.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature express its support for Assembly Bill 765/Senate Bill 2948 regarding the practice of nurse practitioners in New York State; and be it further

- The USDA should temporarily increase the product Price levels of the Dairy Product Price Support Program
- The USDA and the State of New York should immediately increase domestic dairy product purchases for governmentsponsored nutrition programs
- Passage of United States Senate Bill 1722, known as the Federal Milk Marketing Improvement Act of 2007, which will require the Secretary of Agriculture to determine the price for all milk used for manufacturing to be based on the national average cost of production, thereby increasing the price per hundred weight; and be it further

WHEREAS, the same law required that all school sponsored activities have at least one person present that is trained to use an AED; and

WHEREAS, New York State does *not* require as part of the continuing education and certification process that all teachers and school personnel be trained in CPR and AED use; and

WHEREAS, teachers and other school personnel are close to our children and therefore their proper training in CPR and AED use is critical and could save a life; and

WHEREAS, the cost of this training would be negligible if required as part of the certification and recertification process of teachers and school personnel.

RESOLVED, that the Erie County Legislature does hereby support the adoption by the New York State Legislature and/or the Board of Regents of Education to amend State law so that all teachers and school personnel be required to undergo training and recertification in CPR and AED use; and be it further

WHEREAS, the County Legislature of the County of Erie, New York, has heretofore duly authorized the issuance of its general obligation revenue anticipation notes for fiscal year 2009 cash flow financing needs in the amount of \$75,000,000 pursuant to Resolution No. 177-209 adopted by the County Legislature on June 25, 2009 (said revenue anticipation notes being hereinafter referred to as the "County RANS"); and

WHEREAS, said County Legislature has heretofore received from the County Executive a Declaration of Need (Comm. 19E-14) for cash flow financing assistance in the amount of \$65,000,000 from the Erie County Fiscal Stability Authority ("ECFSA") necessary under the ECFSA enabling statute in order to authorize ECFSA to provide such financing assistance; and

WHEREAS, a financing plan has been structured through negotiations between the County and ECFSA which provides for (i) the sale of the County RANS in the amount of \$65,000,000 to the ECFSA and application of the proceeds from such sale to the financing of the County's fiscal year 2009 cash flow needs; and (ii) negotiated sale by ECFSA of its bond anticipation notes (the "ECFSA BANS") to investors in order to provide ECFSA with sufficient proceeds to purchase the County RANS (the "ECFSA Cash Flow Financing Plan");

NOW, THEREFORE, BE IT

RESOLVED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ERIE, NEW YORK AS FOLLOWS:

Section 1. The Declaration of Need for Financing Assistance and request by the County Executive for the ECFSA to undertake a financing of fiscal year 2009 cash flow needs of the County is hereby approved in accordance with Section 3961 of the Public Authorities Law and the ECFSA Cash Flow Financing Plan.
