A RESOLUTION TO BE SUBMITTED BY LEGISLATORS WHYTE, GRANT, LOUGHRAN, MARINELLI, MAZUR, & KOZUB

WHEREAS, in decades past, Erie County government created a Citizens' Advisory Board for the Erie County Holding Center and the Erie County Correctional Facility to work with County officials on improving working conditions for Sheriff's deputies and conditions for inmates and advocate for best practices to the betterment of all involved; and

WHEREAS, in the wake of several issues and concerns raised about conditions at both the Holding Center and the Correctional Facility have spurred a group of citizens, elected officials and community organizations to seek to work collaboratively with the County Sheriff's Office and the staffs of both facilities to improve conditions, and improve communications with the community.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature, per authority granted to it by County Charter, Section 2305, "to better fulfill the purposes responsibilities and goals of each department of the county," create an Erie County Community Corrections Advisory Board for the Holding Center and Correctional Facility; and be it further

RESOLVED, that it is the intent of the Legislature to establish the Erie County Community Corrections Advisory Board (the "Advisory Board") for the purpose of reviewing the corrections facilities, their programs and their services, to offer suggestions and advice for the improvement of such programs; and further to allow an additional forum for public comment and suggestion with regards to matters at the Erie County Correctional Facility and the Erie County Holding Center; and be it further

RESOLVED, that the Advisory Board shall act as a conduit between the County administration, the County Legislature and Erie County residents, responding to community concerns, helping the Sheriff's department disseminate information to the community, taking complaints from families of incarcerated individuals and staff members, providing community oversight of commissary funds and investigating, making findings and offering recommendations to Jail officials regarding best practices and standards; and be it further

RESOLVED, that the Advisory Board shall be created consisting of thirteen (13) voting members, appointed in the following manner:

- 1. One Member to be appointed by the Chair of the Erie County Legislature;
- 2. One Member to be appointed by the Erie County Legislature upon the recommendation of the Erie County Executive;

- 3. One Member to be appointed by the Erie County Legislature upon the recommendation of the 8th Judicial District Administrative Judge;
- 4. One Member to be appointed by the Erie County Legislature upon the recommendation of the Chief Judge of Buffalo City Court;
- 5. One Member to be appointed by the Majority Leader of the Erie County Legislature upon the recommendation of the Erie County Prison Rights Coalition;
- 6. One Member to be appointed by the Minority Leader of the Erie County Legislature upon the recommendation of the Network of Religious Communities;
- 7. One Member appointed by the Chair of the Public Safety Committee of the Erie County Legislature upon the recommendation of the Teamsters Local 264 and the CSEA, the unions that represent the staff of the Holding Center and the Correctional Facility;
- 8. One Member to be appointed by the Erie County Legislature upon the recommendation of Prisoners Are People Too organization;
- 9. One Member to be appointed by the Erie County Legislature upon the recommendation of the Legal Aid Bureau;
- 10. One Member to be appointed by the Erie County Legislature upon the recommendation of the Community Action Organization (CAO) of Buffalo & Erie County;
- 11. One Member to be appointed by the Erie County Legislature upon the recommendation of Hispanics United of Buffalo (HUB);
- 12. One Member to be appointed by the Erie County Legislature upon the recommendation of the Action for Mental Health; and
- 13. One Member to be appointed by the Erie County Legislature upon the recommendation of the National Association for the Advancement of Colored People (NAACP);

and two (2) non-voting members appointed in the following manner:

- 1. One Member appointed by the Erie County Legislature upon the recommendation of the Erie County Sheriff; and
- 2. One Member appointed by the Erie County Legislature upon the recommendation of the County Attorney;

and be in further

RESOLVED, that each organization identified above demonstrate institutional credibility by filing with the Clerk of the Erie County Legislature a copy of their certificate of incorporation or other documents which demonstrate longevity, broad based community support, or recognition by other state/municipal agencies; and be it further

RESOLVED, that all appointed members must meet the minimum requirements set forth in Section 2305 of the Erie County Charter including:

- Each Advisory Board voting Member shall be a resident of Erie County at the time
 of appointment and shall remain a resident of Erie County while holding a position
 as a member of the Advisory Board;
- Members shall serve three-year terms. No Member may serve more than two (2) consecutive terms, including the completion of a term of another voting Member.

Those who have served two (2) consecutive terms may be eligible again after a two (2) year absence to serve on the Board;

• Members of the Advisory Board shall serve without compensation;

and be it further

RESOLVED, that at the first meeting of the Advisory Board in each calendar year, the Board shall elect a voting member as chairperson and another voting member as vice-chairperson. The chairperson and vice-chairperson shall serve in such positions for that year. The vice-chairperson shall serve in the absence of the chairperson and in such other capacity as the chairperson shall delegate; and be it further

RESOLVED, that the Advisory Board shall annually establish a schedule of regular meetings for the year, the Board shall meet a minimum of four (4) times per year; and be it further

RESOLVED, that unless otherwise provided by law, a majority of the current appointed voting members shall constitute a quorum at any duly held meeting of the Advisory Board; and be it further

RESOLVED, that the affirmative vote of a majority of all voting members shall be required for Advisory Board action on any matter; and be it further

RESOLVED, that at each meeting of the Advisory Board, time will be set aside for public comment on issues relevant to the stated intent in the adopted Bylaws of the Advisory Board. If no such individuals or organizations have contacted the Chairperson of the Advisory Board to request time to testify, the Board will forgo the time for public comment at that meeting of the Board. Request to testify can be made to the Chairperson of the Erie County Community Corrections Advisory Board by filing such request with the Clerk of the Erie County Legislature at least five (5) business days prior to the Meeting of the Advisory Board; and be it further

RESOLVED, that the Advisory Board shall adopt standards of conduct and disclosure of interests intended to ensure that the actions of the Advisory Board are carried out in an ethical manner; said standards shall be consistent with any standards recommended for Community Corrections Advisory Boards by the State of New York or by any national organization of Community Correction Advisory Boards; and be it further

RESOLVED, that the Advisory Board may adopt such rules and procedures for the efficient and orderly conduct of its business as it deems necessary or appropriate. Such rules and procedures shall provide reasonable opportunity for public comment and engagement; and be it further

RESOLVED, that at the first meeting of the Advisory Board, it shall adopt a set of Bylaws that do not conflict with Section 2305 of the Erie County Charter and that said Bylaws will be subject to the approval of the Erie County Legislature; and be it further

RESOLVED, that the Advisory Board will produce, annually, a report on the progress of the Board for the previous year and their goals for the upcoming year; said report is to be filed with the Clerk of the Erie County Legislature and is to be reviewed by the Public Safety Committee of the Erie County Legislature; and be it further

RESOLVED, that the Advisory Board functions in an advisory capacity to the Erie County Legislature as well as to the Erie County Sheriff and the Administration of Erie County; and be it further

RESOLVED, that the Advisory Board may undertake functions and activities intend to provide advice and suggestions to:

- improve the programs and functions of the Erie County Correctional Facilities;

 - One Member to be recommended by the Aid to Indigent Prisoners Assigned Counsel
 - One Member to be recommended by the Commissioner of Health
 - One Member to be recommended by the Commissioner of Mental Health
 - The Superintendent of the Erie County Jail Management Division

- One Member to be recommended by the Erie County Director of Probation
- One Member to be recommended by the Chief Administrative Judge for the Eighth Judicial District
- One Member to be recommended by a Union Representing Employees of Correctional Facilities
- One Member to be recommended by the Legislature who is employed at a non profit organization that is involved in alternatives to incarceration
- 2. <u>One (1) Non-Voting Representative</u>. The Advisory Board shall have one (1) ex-officio non-voting representative appointed as follows:
 - One Ex-Officio Representative to be appointed by the Erie County Attorney
- 3. <u>Qualifications of Members</u>. All appointed members must meet the minimum requirements set forth in Section 2305 of the Erie County Charter including:
 - Each Advisory Board voting member shall be a resident of Erie County at the time of appointment and shall remain a resident of Erie County while holding a position as a member of the Advisory Board.
 - Members shall serve three year terms each, except that of the members first appointed, 5 shall serve terms of 3 years each, 5 shall serve for terms of 2 years each and 3 shall serve for terms of 1 year each.
 - Members may serve no more than two consecutive terms, or six years in a row, whichever is greater.
 - Members of the Advisory Board shall serve without compensation.
 - Members of the Advisory Board shall be required to complete and file financial disclosures as required by Local Law 10 of 1989, as amended, on an annual basis in accordance with that Law; and be it further

RESOLVED, that at the first meeting of the Advisory Board, the Board shall elect a voting member as chairperson and another voting member as vice-chairperson. - Improve the programs and functions of the Jail Management Division and the County Correctional Facilities

 Executive and the Erie County Sheriff on the comprehensive plan for
 programs and services at the Correctional Facilities in Erie County, complete
 with a budgetary analysis and identification of possible sources of funding

- Receive complaints regarding the Correctional Facilities from the public and refer such complaints to the proper official in the office of the Erie County Sheriff for investigation;
