RE: Supporting Federal Legislation (S.2794) to Provide a Tax Benefit to Hunters Who Donate Venison to Anti-Hunger Programs (INTRO 25-1)

### A RESOLUTION TO BE SUBMITTED BY LEGISLATORS TERRANOVA, MARINELLI, MILLS, KOZUB, WALTER, GRANT, IANNELLO, REYNOLDS, LOUGHRAN & RATH

WHEREAS, nearly 700,000 New York State residents participate in deer hunting every year, contributing over \$1.5 billion to the state's economy, supporting thousands of job and helping to manage the state's overcrowded deer populations; and

WHEREAS, according to the New York State Department of Environmental Conservation, more than 220,000 deer were taken in New York State in 2008; and many hunters wish to donate game that they cannot utilize themselves; and organizations, such as the Venison Donation Coalition, pay for the processing of a deer (venison) that will be given to a program that feeds impoverished, hungry people; and WHEREAS, two years ago, New York State funded the Venison Donation Coalition in the amount of \$100,000; however, due to the state's fiscal constraints, the funding for 2009-2010 stands at \$21,000, an astonishing 80% cut in a program that has helped curb deer overpopulation at the same time it provides a high-quality protein source to those served by anti-hunger organizations; and

WHEREAS, private donations to the Coalition and other anti-hunger organizations have also diminished during the current recession while the demand for food is on the rise; and

WHEREAS, U.S. Senate Bill S.2794, sponsored by Senator Charles E. Schumer would exempt any income a deer processor would receive if venison, the final product, would be donated to an anti-hunger organization, and would also allow the hunter to deduct the processing fee from his or her taxable income; and

WHEREAS, the donation of venison has gained importance during the recession, and thousands more individuals and families have been forced to turn to food pantries and soup kitchens for sustenance.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature go on record in support of federal legislation (S. 2794) to support a major economic engine in the state – hunters – by providing a tax incentive to hunters and processors who donate venison to anti-hunger programs; and be it further

# A RESOLUTION TO BE SUBMITTED BY LEGISLATORS MAZUR, MARINELLI, MILLS, KOZUB, WALTER, TERRANOVA, GRANT, IANNELLO, REYNOLDS, LOUGHRAN & RATH

WHEREAS, the general public continues to be concerned about the number of cases of swine flu reported in Erie County, as well as the deaths that have arisen from the infection within the last year; and

WHEREAS, constituents have contacted members of the Erie County Legislature to find out about the availability of swine flu clinics in Erie County, particularly following media reports of a mass vaccination that took place in Niagara County on November 21; and

WHEREAS, it is our understanding that the Erie County Department of Health has implemented a policy decision to prioritize the dissemination of flu vaccine to primary care providers in Erie County – particularly pediatricians and ob-gyn practices – so that high priority groups could receive vaccinations prior to the general public; and

WHEREAS, notwithstanding the fact that New York State has not received sufficient quantities of vaccine from the federal government to fill the pending orders from regions throughout the state, it is fitting and proper for Erie County Legislators, in their oversight role, to receive a thorough and up-to-date report from the Commissioner of Health for Erie County, Dr. Anthony J. Billittier IV, regarding Erie County's ability to obtain and distribute supplies of vaccine to meet the demand from health care practitioners and the general public, especially those at high risk; and

WHEREAS, legislators have an interest in being briefed on the county's distribution plan and amount of vaccine distributed thus far, as well as the Health Department's assessment of the manner by which individual schools have handled outbreaks and any other information about this public health matter deemed appropriate by the members of the Erie County Legislature.

WHEREAS, the Niagara River is one of our region's greatest assets, one which residents throughout Erie County value and utilize; and

WHEREAS, people living in waterfront neighborhoods, from Southern to Northern Erie County, desire increased access to the waterfront for recreational activities such as fishing, boating and swimming; and

WHEREAS, several points of entrance to the Niagara River are located within the City of Buffalo, including those along Niagara Street, Porter Avenue and the Outer Harbor; and

WHEREAS, multiple projects are currently planned at these locations, projects that are designed to bring increased accessibility to the waterfront and recreational opportunities for residents and visitors alike; and

WHEREAS, plans for a Niagara River Boardwalk have been on the drawing board for years, and have garnered support from community leaders, elected officials, business owners and residents alike; and

WHEREAS, the Common Council of the City of Buffalo has, in the past, reviewed plans for a Niagara River Boardwalk and has similarly called for federal support for this important project; and

WHEREAS, with federal dollars flowing into our community from the Economic Stimulus Plan approved by Congress and the President earlier this year, the time may be right to tap into this federal revenue stream for the Niagara River Boardwalk project.

WHEREAS, this utility will be provided at mutually agreed upon service levels and at a lower cost than current services, for a contractual term of services of sixty (60) months, with an annual projected savings of \$ 180,000.
