CERTIFICATE AND NOTICE OF RESTRICTION

This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby restrict that portion of the highway in the Town of West Seneca, said County, known as Erie, and described as follows:

Restriction:

That portion of Leydecker Road (CR 364), over Cazenovia Creek, (BIN 3328840) from Seneca Street to East and West Road will be restricted beginning Monday, October 9th, 2017 through Friday, November 17th, 2017 or until complete. This restriction is for the purpose of bridge deck repairs. The contractor is Union Concrete and Construction Corp and can be reached at 716-822-5755. Traffic will be down to a single lane with temporary traffic signals.

A restriction is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
