Proposed 2013 Budget reviewed by Legislature

On Oct. 15, 2012, the County Executive released his first ever budget, which includes a proposed tax increase. The \$1.4 billion budget increases the tax levy by \$8 million and asks taxpayers to pay an additional 3.4 percent on their property tax bill in 2013.

"I 100 percent oppose a tax increase," said Legislator Lorigo after reviewing the

proposed budget.


Legislator Lorigo and his colleagues in the Minority Caucus are working to amend the proposed budget, eliminating the proposed tax hike. The Legislature is expected to vote on the budget on Dec. 4, 2012.

Before finalizing the budget, the Legislature will hold hearings with department heads and commissioners from Tuesday, Nov. 13 through Thursday, Nov. 15.

On Monday, Nov. 19, the public hearing will be held at 5 p.m., offering residents an opportunity to speak on

the proposed budget. The hearing is held at 92 Franklin St., Fourth Floor, Buffalo, NY 14202.

Anyone unable to attend, can submit their statement in writing to the Clerk of the Legislature, 92 Franklin St., Fourth Floor, Buffalo, NY 14202.

Rabies Clinics serves record number of pet owners

The 2012 free rabies clinics administered a record number of vaccinations to dogs, cats and ferrets at six clinics held throughout Erie County.

In total, 5,680 pets were vaccinated.

"I attended the West Seneca clinic and there was a line out the door and through the parking lot, formed by responsible and patient pet owners. I watched as the veterinarian administered the

vaccinations, efficiently moving through the line. When I learned that the volunteers successfully vaccinated 1,369 animals at that one clinic I was amazed," said Legislator Lorigo.

Legislator Lorigo thanks the staff and volunteers from the County Department of Health, Niagara Frontier Veterinary Society and the SPCA Serving Erie County for making these clinics huge successes.

Yellow Dot program now recognized in Erie County

Legislator Lorigo announces that Erie County is now operating a Yellow Dot program to assist residents involved in an accident or suffering from a medical emergency in their vehicle or residence.

Made possible by the New York State Sheriffs' Association, the Yellow Dot program is simple, yet

lifesaving. Anyone who chooses to participate just needs to place the round, Yellow Dot circle (pictured right) on their driver's side, rear vehicle window or at the entrance of their residence, to alert first responders to the Yellow Dot form (also pictured right) that is stored in the glove compartment or on the refrigerator in the

residence. The form includes pertinent medical information that will assist first responders in treating the patient. In an emergency, every second counts.
