Protecting the agriculture community



During an Agricultural Tourism tour in Erie County, Legislator Mills discussed the importance of supporting farms and agriculture businesses.

Erie County is home to a vast farming industry, including vineyards, dairy farms, and thousands of acres of vegetables and fruit. Much of Legislator John Mills' district is rural, housing agricultural businesses.

How farmers operate their business was recently threatened when the U.S. Department of Labor

proposed policy changes that could have prohibited teens from working the family's New regulations would have removed much-needed employment opportunities for youths by prohibiting teens from engaging in such simple tasks. The language in the proposal was broad enough it would have prohibited teens from common chores like carrying firewood, collecting eggs or shearing sheep.

Legislator Mills discussed the issue with the Department of Labor's proposal in his May 2012 column, available to read at www.erie.gov/legislature/district11.

More than just threatening the farming industry, the federal government again attempted to impose regulations that would harm small business operations.

"Once again, the federal government put forth a policy without purpose, threatening more harm than good. Those that proposed the changes obviously did not apply common sense, and their ineptness forced farmers and members of the agriculture community to take time away from their jobs to fight this ridiculous policy. It should not be the citizens' responsibility to demonstrate a 'public outcry' to prevent the government from intruding into their family business," Legislator Mills said.

Fortunately, the proposal was removed from consideration last month.

County offers free rabies vaccinations

Legislator Mills announces that the County has released the schedule for 2012 free rabies clinics for dogs, cats, and ferrets.

Organized by the Erie County Department of Health, in partnership with the Niagara Frontier Veterinary Society and the SPCA, serving Erie County, the clinics are scheduled on the following days:

The following requirements must be met in order to receive the rabies vaccination: pets must be at least 3 months old; and proof previous rabies vaccination must be provided to receive a three-year certificate; otherwise a oneyear certificate will issued. All dogs, cats and ferrets must be restrained using a leash and/or pet carrier.

Legislator Mills is attending the board meetings of the 15 towns and villages in his district on a rotating schedule to provide updates to board members and attendees on county issues.

"My new district is the largest geographically, approximately one-third of the landmass in Erie County. In order to reach residents of every boundary, I have been touring the district to meet with residents in their

hometowns. There are a lot of issues before the County that residents need to be aware of and I am looking forward to discussing them in detail," Legislator Mills said.

Legislator Mills will arrive before the beginning of each meeting and stay through the duration to meet with constituents before and after.

Having attended meetings in Sardinia and Evans, he will attend the Boston Town Board meeting on Wednesday, May 16; Town of Collins on Monday, June 4; and Town of Orchard Park on Wednesday, June 6.

The schedule is announced on Legislator Mills' website, www.erie.gov/legislature/district11. Individual meetings can also be scheduled at a time and location that is convenient to residents.

Among the issues discussed are infrastructure repairs and budget projections.


