This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby restrict that portion of the highway in the Town of Boston/Concord, said County, known as Erie, and described as follows:

CLOSURE:


That portion of Boston State Rd. (CR-227) / Springville Boston Rd. (CR-228) will be restricted from Boston Cross Rd. to Rte. 39 beginning Monday, August 21, 2017 through September 15, 2017 or until complete. Lane restriction is for the purpose of milling, paving & concrete gutter replacement. Watch for flag persons. Destro & Brothers Construction will be doing the work.

Restriction is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
