This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby close that portion of the highway in the Town of Collins, said County, known as Erie, and is described as follows:

CLOSURE:

That portion of Taylor Hollow Road (CR-503) will be closed from US Route 62 to Buffalo Street, beginning Monday, June 19th, 2017, through Friday, September 15th, 2017 (or until complete), for the purpose of bridge maintenance and repairs. Road will be closed to traffic due to repairs on two bridges (BIN-3328320 and BIN-3328330). Oakgrove Construction is the contractor and can be reached at 716-652-2200.

Closures are executed under Article V, Section 104, of the Highway Law in order to permit a proper completion of work of improvement thereon.
