Senior Van Ridership Guidelines

Below are the basic rules instituted by Erie County and the Towns of Clarence & Newstead regarding use of the Senior Van Services, which runs on Tuesdays, Fridays and Saturdays in the Town of Newstead. This is a door-to-door van service which is available to seniors who are unable to use conventional means of transportation. Health related trips are given priority in scheduling.

The basic rules are:

1. Riders 60 years and older, must be able to board and exit the van without driver assistance. If you need assistance boarding or exiting the van, you are required to have someone present to assist you on and off the van at all stops. Drivers are not allowed to put themselves in a situation that may cause them potential physical harm.
*When necessary there is the availability of a wheel chair van for those needing special assistance, however, several days prior notice is required to make arrangements for this service.
2. Riders must be able to access the sites they are visiting without driver assistance. If you need assistance in accessing the site you are visiting you are required to bring someone with you to provide that assistance. *The driver's responsibility is to get you to and from your location only.
3. When you are dropped off at a location you must be picked back up at that location, unless you have made specific arrangements to be picked up from a different site with the van driver.
4. There is a recommended donation of \$3.00 each way for use of the van so, if you are using the van for round trip service the suggested donation is \$6.00.
