Mechanical Cleaning of Sewer Lines for 2016

Erie County, New York Sewer Districts will require a vendor to provide the cleaning of sewer lines during the 2016 year. Vendor is to provide all manpower and equipment needed to mechanically clean sewer lines to remove accumulations of roots and debris.

Cleaning is to be accomplished by the use of **rods and buckets**. The use of high pressure sewer cleaning equipment is **not** an acceptable alternative for this service.

Sewer District will call vendor for service on an "As Needed @ Basis" during 2014. It is anticipated that service will be required during normal working hours – 9 to 5, Monday through Friday.

Vendor must comply with all OSHA requirements regarding confined space entry. **Confined Space Certification Form**, which is included as part of this bid document, must be completed and returned with bid response.

The successful bidder will be required to provide proof of insurance as per coverage requirements of Erie County Standard Insurance Classification A @ (See Exhibit AIC@).

The Sewer Districts listed below will participate in this service, however any other Erie County Sewer District that may require this service during 2016 will do so under the same price, terms and conditions.

Questions regarding the work required should be directed to contact person listed for each district.

Vendor is requested to quote an hourly rate to be charged for this service during working hours as well as the hourly rate for off hours. The rate quoted is to be inclusive of all labor, materials, equipment, etc., necessary to do job. No additional charges will be made. Hourly rate quoted to remain firm through **December 31, 2016**.
