REACTOR SAND

Reactor Sand Pelletized as follows:

A hard silica sand to be fluidized at 1500 F Degrees fluid bed. Moisture content not to exceed 1% at shipping point. Sand to be well washed and free of chlorides. Sand must not fuse or tend to fuse at 1800 F Degrees. U.S. Mesh – per cent retained - 8 + 20 - + 0 to 20 – 30 – 20 + 30 - + 1 to 30 – 30 + 40 - + 10 to 10
- 20 - 40 + 50 - + 10 to 10 - 20
