Eagle St., Buffalo, New York, on the 15th day of SEPTEMBER, 2015 at 10:30 in the forenoon of that day – all the right, title, and interest which LIBERATORE, VICTOR had on the 11/5/2014 or at any time thereafter of, in, and to the following property, to wit: All that tract or parcel of land, situate in the Town of Hamburg, County of Erie and State of New York being part of Lot No. 56, Township 9, Range 7 of the Holland Land Company's Survey and further distinguished as part of Subdivision Lots Nos. 59,60,61,62, 63, and 64 as shown on a map filed in Erie County Clerks' Office under Cover NO. 925 bounded and described as follows: BEGINNING at a point in the west line of McKinley Parkway (120 feet wide) where said west line intersects a line parallel to the south line of Subdivision Lot No. 59 and distant 33 feet north of the south line of Lot No. 59, as measured at right angles thereto; thence westerly along said parallel line a distance of 422.94 feet to a point in the east line of Burke Parkway (50 feet wide) as abandoned; thence northerly along the east line of said Burke Parkway and along the west line of Subdivision Lots Nos. 59, 60, 61, 62, 63 and 64 a distance of 593 feet to the northwest corner of said Subdivision Lot No. 64; thence easterly along the north line of said Subdivision Lot No. 64, a distance of 219 feet to a point; thence southerly at right angles to the last described line 13 feet to a point; thence easterly at right angles to last described line 190.75 feet to the east line of McKinley Parkway; thence southerly along the east line of McKinley Parkway 580.15 feet to the point or place of beginning.
