- All buyers must have a valid picture I.D., NYS Driver's license; NYS pistol Permit, etc. and produce same prior to bidding.
- Only those persons with a valid NYS pistol permit or FFL will be allowed to bid or acquire handguns.
- Sales tax to be added unless a properly completed ST-120 form is produced at time of sale.
