BUSINESS FROM THE FLOOR

Steffan Mychajliw, Erie County Comptroller, resident of Hamburg, NY – involved in the effort to retain the Skyway. Substantial funds have gone into repair to the bridge and substantial money would go into its demolition. Requesting the Board pass a resolution in support of keeping the Skyway as it is a roadway that many in the area travel regularly.

Thomas Weisbeck, 11452 Broadway – (owns vacant property on Cayuga Creek) Posed three (3) questions: Why were residents of the Cayuga Creek Water District not notified of the lateral restriction? Understanding that the Cayuga Creek Water District is in an agricultural district, understands the lateral restriction as not allowing property owners with vacant land to hook into the line without jumping through a lot of hoops and justifying they cannot install a well. And finally, why was this information not provided up front, knowing that it was an agricultural area?

Jennifer Strong, Town Attorney – noted it was a recommendation from the Dept. of Agriculture and the lateral restrictions is something that has been adopted for every water district in the Town. There is a very easy waiver procedure that is decided by the Town Board.

Colleen Rogers, Deputy Town Supervisor – added that the Town Engineer expected they may recommend the lateral restrictions because they have on every other water district. But it's a simple fix like Jennifer Strong has stated. Added most people don't fully understand how it works, if the Town Engineer were present he could explain it better, but it's not a big, very easy fix.

Angela Schuster, 5 Cayuga Creek Rd – does the lateral restriction stop property from being sold in lots? Property has been in the family for 100 years. Does not make enough money to balance the cost of the water; they may be forced to do something they don't want to.

Jennifer Strong, Town Attorney – there is a sub-division procedure that the Town approves, the lateral restriction does not stop property from being divided and sold as lots.

Dean Adamski, Supervisor – This is not much of a restriction; the Town Board would never turn it down. It's done by a simple resolution that a house can be built on the property. An application would be filled out; it would be reviewed at a Work Session and then approved via resolution at a regular Town Board Meeting.
