Dave Kocher, Meadow – Questioned the Board member's support of the 5 member board? Each Board member stated they were in favor of the 5 person Board.

Judith Fleming, Main St. – Questioned why, if the Board is in favor of 5 person Board, none of the Board members presented this to the Alden residents? Supervisor Adamski stated other Town Supervisor's advised the best way to do this was by resident petition and they didn't feel there was enough time to educate the residents. Councilwoman Waiss responded stating she does not use Facebook for political views, she maintains only a private Facebook page socially. She went on to add that the Towns the Board was speaking with were advising not to address the 5 person Board now as there isn't enough time to educate residents properly. Ms. Goff went on the question then why if the Board was made aware by Mr. Kocher in May, did the Board not begin to educate the residents at that point? Councilwoman Waiss stated she had no way of knowing that the residents wanted this.

Robert Johnson, E. Laray – With regard to the Eck HOP, what happens next? He is in favor of Mr. Eck being granted his HOP.
