THE TOWN CLERK READ THE NOTICE OF PUBLIC HEARING

Councilman Adamski asked for to public comment:

Bud Milligan, Blossom Lea – began by stating he noticed Councilman Adamski has 14 or 15 committees that he is responsible for and asked how he does it? Councilman Adamski stated that Rick did most of it. Mr. Milligan went on to state that as Town Supervisor you oversee everything and congratulated Councilman Adamski. Mr. Milligan went on to state that the purpose of the Planning Board is to look at subdivision plans, site plans, special use permits & zoning plans; it's a lot of work and it's how the Town grows. Their role in reviewing all this information is a critical part of keeping our Town clean, neat and a good place to live and raise a family. He stated he's not for more "big brother" but with a 3 person Board this group of people should be invaluable with the work they do. He went on to state that CEO Snyder has a hard job to do. He depends on work the Planning Board does as well as the Town Court to help enforce Town Codes. He referenced several properties within the Town that are in violation of Town Code. CEO Snyder noted that all properties have cases in Court at this time. Mr. Milligan went on to state that CEO Snyder needs help from the Planning Board and Court to enforce the laws of the Town. The Planning Board should be the backbone of the Town and they should work with CEO Snyder to help him keep people in compliance with the Town laws. Mr. Milligan made reference to the Village stating they have tough laws that are enforced and it shows because it is neat and clean. He went on to state that he believes this Board should not be decreased to five (5) members but consider increasing to nine (9) who have more authority.

Councilman Adamski advised that the Planning Board is an advisory board that does not write or enforce laws. Laws are presented to them for review.

Michael DeWitt, Planning Board - added the Board has drafted laws for Board review in the past.

Councilman Adamski went on to ask how frequently all seven members of the Planning Board currently attend all the meetings?

Michael DeWitt stated he did not keep track of attendance.

Councilman Adamski went on to state he appreciated the input and the Board will definitely discuss the points brought up by Mr. Milligan. He also went on to state the problem properties are being looked at.

2. The Town Board hereby authorizes the Alden Town Clerk to advertise for bids as outlined in the attached Instructions to Bidders;

3. The Town Board hereby authorizes the Town Clerk to publish Notice in the Alden Advertiser. Said Notice must be published more than five (5) days prior to Friday December 20, 2019 and must state the time when and place where the sealed bids will be publically opened and read by the Deputy Town Clerk;

4. The Town Board hereby authorizes the Town Clerk to receive sealed bids, until 2:00 PM Prevailing time on Friday, December 20, 2019. All bids must contain the Non -collusive Bidding Certification;

5. The Town Board hereby authorizes the Town Supervisor to sign any and all documentation to effectuate the sale or auction, including signing over the title; and

6. This resolution shall take effect immediately.
