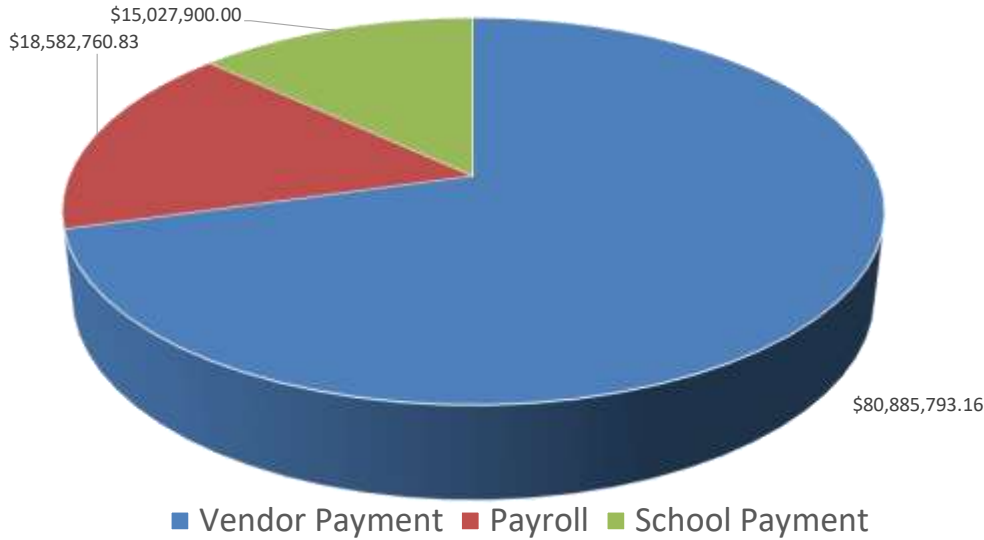
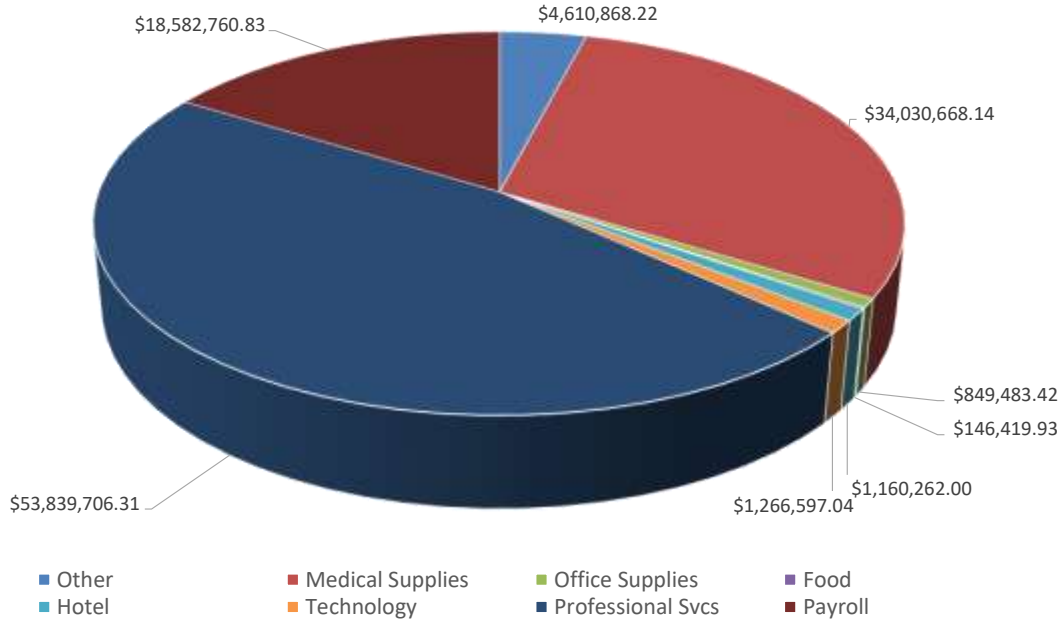


COVID-19 Expenditures as of November 20, 2020
