Local Law No. 2 of the year 19 95. **ERIE COUNTY CLERK'S OFFICE**

A local law in relation to electing a retirement incentive program pursuant to (Insert Title) Chapter twelve of the laws of nineteen hundred ninety-five.

Be it enacted by the LEGISLATURE of the

Section 1. The county of Erie hereby elects to provide the benefits of chapter twelve of the laws of nineteen hundred ninety-five to its eligible employees pursuant to chapter twelve of the laws of nineteen hundred ninety-five.

Section 2. The commencement date of the retirement incentive program shall be the twenty-fourth day of April nineteen hundred ninety-five.

Section 3. The open period during which eligible employees may retire and receive the additional retirement benefit shall be forty-eight days, to commence on and include the twenty-fourth day of April nineteen hundred ninety-five, and to end on and include the tenth day of June nineteen hundred ninety-five.

Section 4. In interpreting this local law, the calendar dates set forth as the opening and closing days of the open period as set forth in this local law shall be deemed controlling in determining the length of such open period, it being the intention of the legislature that the last date on which eligible

employees shall work shall be no later than the ninth day of June nineteen hundred ninety-five, and that the first day of retirement for such eligible employees shall be no later than the tenth day of June nineteen hundred ninety-five.

Section 5. The county of Erie will fund the retirement incentive program provided by chapter twelve of the laws of nineteen hundred ninety-five by paying to the New York state and local employees' system five annual payments, the amount of which shall be determined by the retirement system actuary. The first said payment is due the fifteenth day of December nineteen hundred ninety-six.

Section 6. This local law shall take effect immediately.




